The Farm Service Agency (FSA) published a [proposed rule](#) in the Federal Register on Oct 1, 2002 for the Bioenergy Program (Program) to bring the Program's regulations into compliance with the Farm Security and Rural Investment Act of 2002 (the Act). The Act continues the Program for Fiscal Years 2003 through 2006.
