OLCC issues 21 sanctions for liquor law violations

PORTLAND, Ore. - At their monthly meeting July 14, the commissioners of the Oregon Liquor Control Commission ratified the following 21 sanctions to Oregon licensees.

Yun Wah Chinese Restaurant, 2288 Country Club Road, Woodburn, will pay a civil penalty of \$4,950 or serve a 30-day suspension because Mon Yun Quan, president of Yun Wah Corporation, was convicted of two Class A Misdemeanors - Assault IV and Menacing. Licensees permitted disorderly activities on the premises when Mon Yun Quan cut licensee Siu Wah Quan on the hands with a knife and yelled at employee Luo Wu, grabbing her by the shirt and neck, throwing her to the ground and poking her body with a knife in several places. Mon Yun Quan ran a knife across Luo Wu's forehead and threatened to kill her.

Loafers Bread & Bistro, 222 SW Washington St., Albany, will receive a letter of reprimand for allowing six employees to sell, mix or serve alcoholic beverages or supervise those who do without a valid service permit as well as allowing an employee under 18 years old to take orders for, sell or serve alcoholic beverages. Licensees Heidi Hyre and Steven Hyre of Loafer's Bistro, Inc. have surrendered the liquor license. The letter of reprimand will become part of the licensee's permanent OLCC file.

Hubbard Indoor, 2814 Industrial Ave., Hubbard, will pay a civil penalty of \$3,135 or serve a 19-day suspension for failure to verify the age of a minor before allowing him to buy or be served an alcoholic beverage as well as allowing an employee under the age of 18 to take orders for, sell or serve alcoholic beverages. Licensees are Cynthia Gillespie and Craig Gillespie of Shoot Out Team Sportsplex, LLC.

Corbett Fish House, 5901 SW Corbett, Portland, entered a stipulated settlement agreement and will pay a civil penalty of \$2,640 or serve a 16-day suspension for licensee, Gregory Charles Boyce, drinking while on duty at the licensed premises. Licensee also permitted member Gregory Charles Boyce to sell, mix or serve alcoholic beverages or supervise those who do without a valid service permit. Licensees include Dana Boyce, Gregory Charles Boyce and Charles Carter Boyce of Corbett Fish House, LLC.

Papa Son's, 12525 SE Powell, Portland, will receive a letter of reprimand in OLCC's permanent file for a service permittee selling, serving or making alcoholic beverages available to a visibly intoxicated person as well as President Kenneth Trefz selling, mixing or serving alcoholic beverages without a valid service permit. The liquor license has expired and Trefz no longer holds a liquor license. The permittee who made alcohol available to a visibly intoxicated person entered a stipulated settlement agreement and will pay a civil penalty of \$175 or serve a seven-day suspension.

99 Food Market, *14521 SE McLoughlin Blvd., Milwaukie*, will pay a civil penalty of \$1,485 or serve a nine-day suspension as agreed in a stipulated settlement agreement. Licensees Jae Y. Han and Soon K. Han failed to maintain staff on the licensed premises who could communicate effectively with Commission regulatory employees during business hours.

Blue Dog Distributing, 306 SE Ash St., Portland, will pay a \$1,155 civil penalty or serve a seven-day suspension for failing to send the OLCC monthly privilege tax reports from March 2007 to March 2008. Licensee is Vincent Surratt of Blue Dog Distributing, Inc.

Super Taco & Market, 400 Thunderegg Blvd, Nyssa, will be removed from the Responsible Vendor Program and has paid a civil penalty of \$2,805 for failure to verify the age of a minor before allowing her to buy or be served an alcoholic beverage. Licensees Gildardo Castillo and Sandra Castillo also allowed an employee to sell alcoholic beverages without having him first read, sign and date the Commission-provided brochure and/or maintaining a copy of the signed brochure on the licensed premises.

The following licensees were sanctioned for an employee(s) failing to verify the age of a minor before allowing him/her to buy or be served an alcoholic beverage when he/she reasonably appeared to be under 26:

Pilot Travel Center #390, 2115 S. Highway 395, Stanfield, has paid a civil penalty of \$1,650. Licensees are James A. Haslam III, Mark A Hazelwood, Kenneth M. Parent, Mitchell D. Steenrod and Timothy J. Berry of Pilot Travel Centers, LLC.

Pit Stop Mini Mart, *Highway 140E*, *Bly*, will pay a civil penalty of \$1,650 or serve a 10-day suspension. Licensees are Marilyn M. Thomas and Phillip A. Thomas.

La Amapola Market, 3352 Silverton Rd. NE, Salem, will receive a letter of reprimand as part of the permanent file at OLCC. The liquor license of licensees Guillermina Casas and Eduardo Casas has expired.

Sycan Store, *61274 Hwy 140E*, *Bly*, in a stipulated settlement agreement, will pay a \$330 civil penalty or serve a two-day suspension and will install age verification equipment, utilizing the age verification equipment to verify the age of every patron who reasonably appears to be under 26 years of age. Licensee is William Essig.

Rock N Rogers Diner, *3135 Commercial St. SE, Salem*, will pay a \$1,815 civil penalty or serve an 11-day suspension and will install age-verification equipment, utilizing the age verification equipment to verify the age of every patron who reasonably appears to be under 26 years of age as agreed in a stipulated settlement. Licensees are Jamie Hawley and Melissa Hawley of Hawleywood Foods, LLC.

Lighthouse Grocery & Deli, 705 S. Empire, Coos Bay, in a stipulated settlement agreement, licensees Constance Cunningham and William Cunningham will pay a civil penalty of \$1,155 or serve a seven-day suspension.

7-Eleven Store #2353-35840D, *39695 Proctor Blvd, Sandy,* has paid a civil penalty of \$1,485 as agreed in a stipulated settlement. Licensee is Mohammad Bhopal.

The following licensees were sanctioned for permitting an employee(s) to sell, mix, or serve alcohol or supervise those who do without a service permit:

Flying Pie Pizzeria, 3 Monroe Parkway #S, Lake Oswego, will pay a \$1,650 civil penalty or serve a ten-day suspension. Licensee is Ty Edward DuPuis of TLM Enterprises, Inc.

Tillicum Restaurant & Bar, 8585 SW Beaverton Hillsdale Hwy, Portland, will pay a \$2,310 civil penalty or serve a 14-day suspension. Licensees are Dean MacBale and Rana MacBale of the New Tillicum, LLC.

Cinco De Mayo Family Restaurant, 2102 Adams Ave., La Grande, entered a stipulated settlement agreement and will pay a civil penalty of \$1,155 or serve a 7-day suspension. Licensee is Raul Correa of Cinco de Mayo Family Restaurant, Inc.

Bartini/Urban Fondue/Be Zinful, 2108-2118 NW Gilsan, Portland will pay a civil penalty of \$1,815 or serve an 11-day suspension as agreed in a stipulated settlement. Licensees are Mark Byrum and Daniel Dickerson of Bartini, LLC.

Harvey's Restaurant & Lounge, 436 NW 6th, Portland, will pay a \$3,465 civil penalty or serve a 21-day suspension as agreed in a stipulated settlement agreement. Licensee is Barry Joe Kolin of H.R.A.L., Inc.

The five citizen commissioners are the policy-making body of the OLCC. They meet monthly for one or two days to make decisions on liquor licenses, rules, contested case hearings and appointments of liquor store agents. Commission meetings are held every other month at OLCC's main office, 9079 SE McLoughlin Blvd., Room 103A in Portland. Subsequent months, the meetings will be held via phone.
