1. Confirm 2006 Meeting Schedule

The team finalized the 2006 meeting schedule subject to follow-up regarding spring breaks. Attachment A to this record reflects the final schedule including the follow-up regarding spring breaks. Laura will be checking dates to schedule upcoming meetings with the Directors, the Advisory Committee and the Audit Committee.

2. Updates

a. SPGP January 3, 2006 Launch

DSL conducted meetings the last week of December with 60 frequent filers to kick off the launch of the SPGP January 3rd. DSL will also be holding 15 workshops around the state starting January 9. The SPGP process requires a single application and requires as many as 5 additional resource plans. DSL will be lenient during the first few months of implementation by allowing applications to not be entirely complete upon submission until April 1; however permit decisions will not be issued unless all requirements have been met. Patty Snow commented that she believes the SPGP process will be helpful by requiring fish passage plans and other requirements up-front. John Lilly indicated all application materials will be available on line.

- **b. NPDES Follow Up.** Christine Svetkovich indicated she has followed up with Chris Bayham regarding AOC concerns about NPDES permits.
- **c. Updated ODFW Fish Passage Rules.** Patty Snow reported that ODFW will be adopting updated Fish Passages rules.
- **d.** New **ODFW Director.** The ODFW Commission has appointed an interim ODFW Director.

- e. Updated Stormwater General Permit (1200C) Adopted Effective December 31, 2005. The DEQ Commission adopted a new stormwater general permit on December 31, 2005. It becomes effective January 31, 2006. A key change requires a 14 day public notice for permits involving 5 acres or more.
- **f. Outcome Based Compliance Advisory Committee Expectation.** Laura Lesher indicated that the WRPPIT discussion at its December 21 meeting regarding the Advisory Committee's customer priority for an outcome/based focus is being pursued as follows:
 - → Laura has asked 3 Advisory Committee members that actively pull permits to provide 5-10 examples of how things would be different with an "outcome/based focus" (Frank Flynn, Tim Acker, Amy Connors.)
 - → Pat Allen will share these examples with some Directors and Legislators. Further contact with the Governor's office will not occur until this follow up has been done.
- **g. WRPPIT Measurement Subcommittee.** The Measurement Sub-Group met on January 4 and will be meeting again on January 18 to finalize the measurement plan before bringing a proposal to WRPPIT.
- **h. USERS GUIDE.** Kirk Jarvie reported that the USER's GUIDE is progressing. Chapter assignments have been made and are being written.
- 3. Draft Meeting Record Advisory Committee December 14, 2005

The team approved the meeting record of the December 14, 2005 Advisory Committee meeting for distribution. Once approved by WRPPIT the notes will be distributed to the Advisory Committee. Members will be asked to submit any suggested changes.

5. Review Prior Meeting Minutes: Nov 18, 22; Dec 9, 21 – 2005

Jenny highlighted elements of prior meeting minutes relevant to today's meeting discussion concerning the redesign. These meeting records will be before the team for approval at the January 11 meeting.

6. Review Redesign Road Map and Redesign Materials

Jenny reviewed the following items with the team in advance of a discussion about the "redesigned product":

- Redesign Road Map
- Water Related Permitting Process Purpose
- University of State Authorizations That are the Focus of the Redesign
- Redesign Charge
- Redesign Assumptions
- Redesign Principles
- Product and Process Expectations
- Industry Standard for Product and Process Redesigns
- Optimum Task Flow

7. Confirm Redesigned Product

After confirming customer product and process expectations, the next "redesign" step is to redesign the PRODUCT. The current product is represented in Appendix B. Today's product consists of a conditioned removal-fill permit and multiple other state authorizations, each with their own process and timeframe.

Working with the December 14, 2005 Advisory Committee meeting customer product and process expectations, key concerns about today's products are:

- o that individual agency authorizations often conflict with each other,
- o a single agency's authorization can come late in a customer's project requiring redesign and delays,
- the process of obtaining all necessary approvals can take a great deal of time, impacting the time and cost of a customer's project, and
- o there is limited opportunity to build a project that is collectively responsive to all agency requirements.

WRPPIT brainstormed the following list of possible redesigned products:

- a. 14 permits that feel like 1 or 2 or 3
- b. A continuum of how permit decisions are managed (or a continuum of efficiency)

- c. Safe harbor
- d. Cluster by type of permit
- e. Cluster by complexity
- f. Project appropriate cross-functional team negotiated permit decision with a lead agency
- g. Combine permits
- h. Pay for faster service (WRD)
- i. Option f in one agency

From among these redesign product possibilities, WRPPIT concluded that the new product of the state of Oregon's water related permitting process should be:

Coordinated, Consistent, Concurrent Multiple Decisions

For the customer this will mean:

- while every decision will not occur the same day, they will occur in the same time frame
- all decisions could still be bundled as a state permit

The team felt the redesigned product could serve the frequent filer, the customer with a large project, and the customer with a small project.

The team also agreed that as the team designed the optimum process flow and timing, it will examine opportunities for combining permits, reviews, and authorizations. Each agency should be asking itself: what would you eliminate or combine or delegate to another agency?

DSL Analysis: permit decision required within 90 days after complete application determination

Applicant Response: 25 days requested by DSL for workload planning, not mandatory.
