

Unplanned Scrams per 7000 Critical Hrs





Unplanned Power Changes per 7000 Critical Hrs



















Occupational Exposure Control Effectiveness





Protected Area Security Performance Index

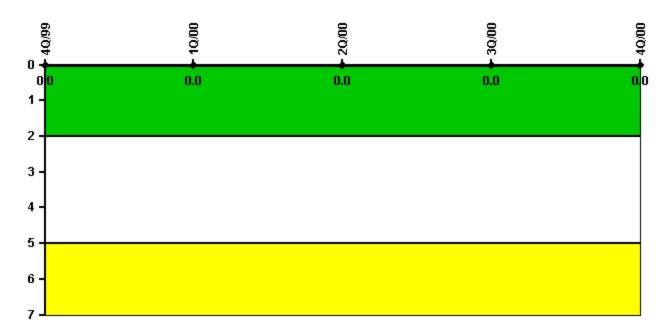


