Recently, the Commission has announced proposed changes that pertain to corporate governance. Although the SEC has announced these changes with the best intentions in mind, I feel that they are reactionary and pose a threat to individual investors as well as large corporations.

The regulations allow for large shareholders to nominate a person of their choosing, regardless of that person's experience or political agenda. First, it allows loopholes for bias and special interests to influence executive decisions. Secondly, it will create a board that may have difficulty working together as a team.
