October minutes – Motion to accept minutes, Rosetta. Second by Randy. Passed. November minutes – Motion to accept minutes Rosetta, motion to approve minutes as corrected, Randy moved. Deborah second. Passed.

Community forum – Deborah noted that the attendees were mostly from licensed programs and the results reflect this. Deborah noted that one attendee noted that a school age program in her rural community was not able to meet licensing codes in schools and they are worried about latch key kids. There was a request not to make licensing too hard so more programs can exist for kids.

Tina asked if parents attended, and maybe one of the first steps is requiring some kind of identification of what the program is to notify parents about whether the program is licensed or not. Katie noted that education is significant.

Beth noted some clarifications occurred about what programs should be licensed under current rules. She also reflected that attendees mentioned that educators from schools should be attending this because it's such an important issue to schools.

Where are funds coming from Sun? Tina noted that OCCF was given money from legislature to fund a community schools position to coordinate statewide and might be worth having them come and report. 625k goes to OCCF which will give out through an RFP (criteria undecided) and 90K is for a position.

Merilee asked if legislation could be legislation to require programs to disclose info to parents that note if criminal history checks are, along with any other qualifications. Consumer protection initiative may be one idea. Katie said a form that requires parents to sign off that they know what is done or not would take it to another step. Rosetta noted that different programs in the same building create confusion. Want to make sure the plan is incremental.

Legislation could do this. Tom noted this could be done through the licensing process. Possibly on two ends of the continuum: legislation for consumer protection, and then if you are to receive DHS reimbursement that you have to be licensed which is an incentive.

School board association has discussed after school agenda.

Tina said legislation could require schools to provide equal access whether the program is licensed or exempt – if free rent of offered then it should be offered to licensed program (if non-profit).

Cheryl noted that the criminal history was raised as a challenge if there are different systems. Every school district does criminal history checks differently. Tom was asked 2 years ago to chair a group to identify if criminal history checks could be done using the same system. After convening the agencies, there was no agreement. Tom needs a legislator to get involved or this group to identify it as a higher priority then other issues the ECE system from OCCF. Position paper was written and Tom gave it to partners for Children and Families. Need a resource allocation dedicated to state police.

Two potential pieces of legislation focused on consumer protection: 1. public disclosure on licensure 2. criminal history checks coordination - this will save schools and state money even if an allocation was needed to the state police to coordination.

Action: Tom will send position paper to Rosetta, who will write a letter to Mickey and inquire where we are in this work. CC Rep. Flores and Kotek.

Update from CCD – Tom

In response to last meeting and report from Salem parents, CCD will go live on Feb. 11 to post child care facility complaints on line. Complaint history is only one piece, click on site, the complaint is shown. They explain the difference between compliance and complaints. History will go back to Jan 2004. The system will also report if license is suspended. The web site will be reflected within the same day complaint is found valid. Anything pending will not be shown. How does a parent know they should call CCD? It says in many places throughout the website. Tom has notified R&R, union but has memo to send out to partners.

The Peninsula Story: Deborah reported that Peninsula benefited 83k from the subsidy package which the board voted to put towards rewards and wage increases for staff who increase their training. Within the last 6 weeks 4 are in degree programs, 12 in /CDA programs. "For the first time it's worth time and training to put training into a training."

A lot to be proud of and the Commission that took a strong leadership role.

What do you wish the Commission would have done better or would like to add to our to do?

- Tom pushing Cares informally but we need to talk differently need incentive for providers to meet training levels to care for Head Start audience. A way to expand universal pre-k in state.
- Tom Universal criminal history checks
- OCCF define exempt school age care
- Cheryl raise training standards for RFCC and CFCC (due to 16 impact ensure training/incentives training access, management tx) Training hrs should be 8hrs/yr and annual inspections.
- Katie if provider license is revoked they never take care of children again
- OCCRRN raise licensing standards for FCC

Priority E: Efficient and Collaborative

- Oregon Ask: Work with Or Registry and QI for school age certificate
- Inclusive Child Care Training/TA support partnerships for early intervention due to Oregon being selected.
- Cheryl: collaborative piece between unions to mentor/assist providers get licensed

- OAEYC accreditation but need education, Cares type incentives, director credential, CFCC certificate
