### Presentation on Lincoln County Marketing Video n- Nina Roll

Nina Roll presented a video developed in Lincoln County with the goal to open a quality child care center. The video has been presented at various business and club meetings in Lincoln County.

The video touches on 3 main points.

- 1. Child care is important to the economic development of our community.
- 2. We need to be concerned who is caring for our young children.
- 3. Today's young children are tomorrow's workforce.

What has occurred to date:

- The superintendent of Newport school district offered \$5,000 and a space for the center in Toledo.
- There is community discussion in the importance of child care.
