NOTICE OF DECISION
Mill Hollow Timber Sale
USDA Forest Service
Heber-Kamas Ranger District
Uinta-Wasatch-Cache National Forest
Wasatch County, Utah

On September 2nd, 2008, Julie King, Heber-Kamas District Ranger, approved harvest of timber on approximately 242 acres. These stands consist of insect and disease infected, suppressed or of low vigor, hazardous, and high risk trees. Harvest of dead, beetle-infested and high risk trees in and around Mill Hollow Campground will reduce spruce beetle susceptibility and create healthier forest conditions. A precommercial thinning would be implemented within the campground to help control the spread of insects by removing trees highly susceptible to insect attack, and by reducing competition and thereby improving the vigor of the remaining trees. Logging slash would be treated on site and/or made available for campground visitors for campfires. Up to one half mile of existing temporary roads may be reconstructed or opened for use and obliterated following sale activities. The project area is located about 14 miles southeast of Woodland, Utah.

This decision is subject to appeal under Forest Service regulations 36 CFR 215. Appeals must meet the content requirements of 36 CFR 215.14. Only individuals or organizations who submitted comments or otherwise expressed interest in the project during the comment period may appeal. Appeals must be postmarked or received by the Appeal Deciding Officer within 45 days of the publication of the legal notice in The Provo Daily Herald. This date is the exclusive means for calculating the time to file an appeal. Timeframe information from other sources should not be relied on. The Appeal Deciding Officer is Brian Ferebee, Forest Supervisor. Emailed appeals must be submitted in rich text (rtf) or Word (doc.) format and must include the project name in the subject line. Appeals may also be hand delivered to the above address, during regular business hours of 8:00 a.m. to 4:30 p.m. Monday through Friday.
