has preformed tests on you before you are allowed to take this medication. Make follow up appointments mandatory.Lab work

mandatory, a colonoscopy mandatory. What ever it takes to get the right medication to the right people. I am that person.

If someone in your family had to live this way, how would you help them. If was your Mother, your wife, your daughter or son,

who had to live in the bathroom, could not go out for a day or evening of fun. To miss weddings, ect. Think of us as your family when you go into that meeting, and please do your best so your family can get the medication

they need to live a normal life. I pray every night for a new drug to come on the market. I have worked in the same pharmacy for

15 and 1/2 years and thank goodness they understand when I call in sick.

I also have glaucoma so that knocks out about 98% of the drugs that help in a little way. Only Lotronex was my salvation.

Please take my letter with you to the meeting so I feel like I am there to represent myself. To tell my story, to plead like I have to do to Glaxo and the FDA, trying to get a special request to get the drug. Thank you so very much for listening to me about my life without Lotronex.
