TREASURY INTERNATIONAL CAPITAL DATA FOR JANUARY

Treasury International Capital (TIC) data for January are released today and posted on the U.S. Treasury web site (www.treas.gov/tic). The next release date, which will report on data for February, is scheduled for April 17, 2006

Net foreign purchases of long-term securities were \$66.0 billion.

- Net foreign purchases of long-term domestic securities were \$78.0 billion, \$20.2 billion of which were net purchases by foreign official institutions and \$57.9 billion of which were net purchases by private foreign investors.
- U.S. residents purchased a net \$12.0 billion in foreign issued securities.
