#### CONSTITUTION OF THE UNITED STATES [ARTICLE IV, SECTIONS 1-2]

SECTION 3. <sup>1</sup>Treason against the United <sup>§ 181. Treason against</sup> States, shall consist only in levying <sup>the United States.</sup> War against them, or in adhering to their Enemies, giving them Aid and Comfort. No Person shall be convicted of Treason unless on the Testimony of two Witnesses to the same overt Act, or on Confession in open Court.

# ARTICLE IV.

SECTION 1. Full Faith and Credit shall be given in each State to the Public §183. And the Congress may by general Laws prescribe the Manner in which such Acts, Records and Proceedings shall be proved, and the Effect thereof. SECTION 2. <sup>1</sup>The Citizens of each §184. Persons held to</sup> State, under the Laws thereof, es-<sup>service or labor.</sup> caping into another, shall, in Consequence of any Law or Regulation therein, be discharged from such Service or Labour, but shall be delivered up on Claim of the Party to whom such Service or Labour may be due.

SECTION 3. <sup>1</sup>New States may be admitted by <sup>§ 187. Admission and formation of new States. <sup>§ 187. Admission and</sup> no new State shall be formed or erected within the Jurisdiction of</sup>

any other State; nor any State be formed by the Junction of two or more States, or Parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress.

<sup>2</sup> The Congress shall have Power to dispose of <sup>\$188. Power of</sup> <sup>Congress over</sup> territory and other national property.</sub> and make all needful Rules and Regulations respecting the Territory or other Property belonging to the United States; and nothing in this Constitution shall be so construed as to Prejudice any Claims of the United States, or of any particular State.

The Court of Appeals for the District of Columbia Circuit has held that the property clause does not prohibit the transfer of United States property to foreign nations through self-executing treaties. Edwards v. Carter, 580 F.2d 1055 (1978), cert. denied, 436 U.S. 907 (1978).

SECTION 4. The United States shall guarantee \$189. Republican form to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive

(when the Legislature cannot be convened) against domestic violence.

## ARTICLE V.

The Congress, whenever two thirds of both §190. Amendments to Houses shall deem it necessary, the Constitution. shall propose Amendments to this Constitution, or, on the Application of the Legislatures of two thirds of the several States, shall call a Convention for proposing Amendments, which, in either Case, shall be valid to all Intents and Purposes, as Part of this Constitution, when ratified by the Legislatures of three fourths of the several States, or by Conventions in three fourths thereof, as the one or the other Mode of Ratification may be proposed by the Congress; Provided that no Amendment which may be made prior to the Year One thousand eight hundred and eight shall in any Manner affect the first and fourth Clauses in the Ninth Section of the first Article; and that no State, without its Consent, shall be deprived of its equal Suffrage in the Senate.
