MILK TOP CONTRIBUTOR TO REGION'S TOTAL CASH RECEIPTS

New England cash receipts from farm marketings totaled \$2.62 billion in 2007, an increase of \$344 million over the revised 2006 value. Cash receipts from milk sales remained the top contributor to overall marketings in 2007, with \$838 million in sales. Greenhouse and nursery sales, at \$615 million, were the next largest cash contributor. Cash receipts from these two commodities comprised 55 percent of all farm marketings in the six state region in 2007.

Crop sales in New England were estimated at \$1.3 billion in 2007, three percent above sales generated the previous year. The greenhouse and nursery industry remains New England's top contributor to crop sales, comprising 47 percent of the total crop sales. Fall potatoes were the second largest contributor, covering 10 percent of all crop sales in the region. Cash receipts from fall potatoes sales in 2007 totaled \$133 million, down two percent from 2006, but 29 percent above 2005 receipts. Wild blueberry cash receipts in Maine topped \$83 million in 2007, reflecting increases in both production and price. Cash receipts from cranberry sales in Massachusetts totaled \$70.9 million in 2007, nine percent below 2006. Improved cranberry prices failed to offset the 20 percent drop in utilized production from a year earlier.

New England livestock sales, also at \$1.3 billion in 2007, were up 30 percent from 2006, driven by the dramatic increase in milk price. Fewer pounds of milk were marketed, however the average milk price received by New England dairy farmers increased by \$6.88/cwt to \$20.87/cwt in 2007. Although fewer eggs were sold in 2007 compared with the previous year, higher prices received translated to a 54 percent increase in chicken egg cash receipts in New England in 2007. Poultry producers saw average egg prices increase from \$0.558/dozen in 2006 to \$0.875/dozen in 2007. Offsetting improved milk and egg cash receipts were reductions in cattle, hogs and sheep revenues. Cattle and calf cash receipts were 12 percent lower in 2007 than a year earlier due to reductions in the number of head marketed in the six state region and weaker calf prices.

Cash receipts generated from milk and fall potatoes secured **Maine's** place as first in the region in 2007. Total cash receipts from all agricultural commodities produced in the state totaled \$684.5 million, 17 percent above the previous year. Milk sales, at \$127.5 million, edged out fall potatoes as the top individual contributor to the state cash receipts' total in 2007. Dairy producers in Maine marketed 582 million pounds in 2007, an increase of 12 million pounds from a year earlier. Producers received an average of \$21.90/cwt for milk sold in 2007, up from \$14.70/cwt for sales the previous year. Fall potato cash receipts followed as the second.

largest contributor at \$124 million, a four percent reduction from 2006. Wild blueberry sales contributed a record \$83 million towards the state's cash receipts total in 2007, 38 percent above the previous year due to increases in both pounds marketed and value per pound. Growers received an average of \$1.07/lb for berries sold in 2007, compared with \$0.805/lb a year earlier. Chicken eggs generated \$80 million in sales in 2007; fewer eggs produced were offset by higher prices resulting in a 56 percent increase in value from the previous year.

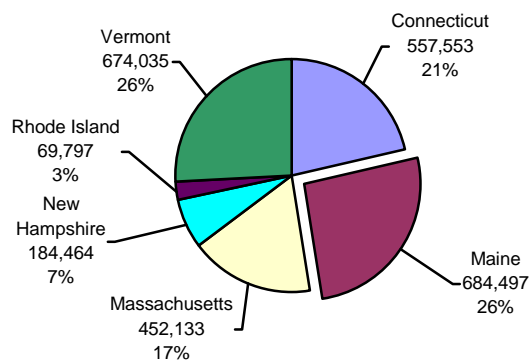
Cash receipts generated from milk secured **Vermont's** place as second in the region in 2007. The value of milk marketings totaled \$518 million in 2007, a 47 percent increase from a year earlier due to improved prices received. Dairy producers in Vermont received on average \$20.60/cwt for milk sold in 2007, compared with \$13.70/cwt in 2006. Vermont milk sales remained the top individual contributor to the state total and New England total cash receipts. Sales from milk comprised 77 percent of Vermont's total cash receipts, and 20 percent of New England's total cash receipts. Farm marketings from crops and livestock totaled \$674 million in the state in 2007, 34 percent above the previous year.

Cash receipts generated from greenhouse and nursery products moved **Connecticut** into third place in the region in 2007. The value from greenhouse and nursery marketings totaled \$258.5 million in 2007, 46 percent of the state's cash receipts total. Milk sales were the next largest contributor to Connecticut's cash receipts, with \$76 million in total revenue generated. Monies received from sales of milk were up 45 percent from the previous year: fewer pounds marketed were offset by improved prices. Farm marketings from all crops and livestock totaled \$558 million in the state in 2007, an increase of five percent from 2006.

Massachusetts followed with \$452 million in total 2007 cash receipts, four percent above the previous year. Greenhouse and nursery sales remained the top contributor to Massachusetts' total cash receipts in 2007, with sales estimated at \$158 million. The next largest contributor was from the sale of cranberries. Growers marketed 1.5 million barrels at an average of \$46.60/barrel, which placed the value at \$71 million in 2007. Receipts from milk marketed in 2007 totaled \$53 million, 34 percent above 2006 due to improved prices.

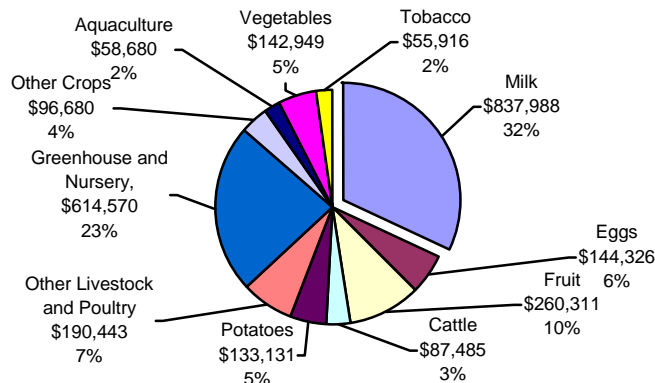
New Hampshire's cash receipts totaled \$184 million in 2007, with greenhouse and nursery sales and milk comprising two-thirds of all receipts. **Rhode Island's** greenhouse and nursery industry dominated the state's agricultural cash receipts, comprising \$46 million of the total \$70 million generated in 2007.

by Commodity in 1,000 Dollars



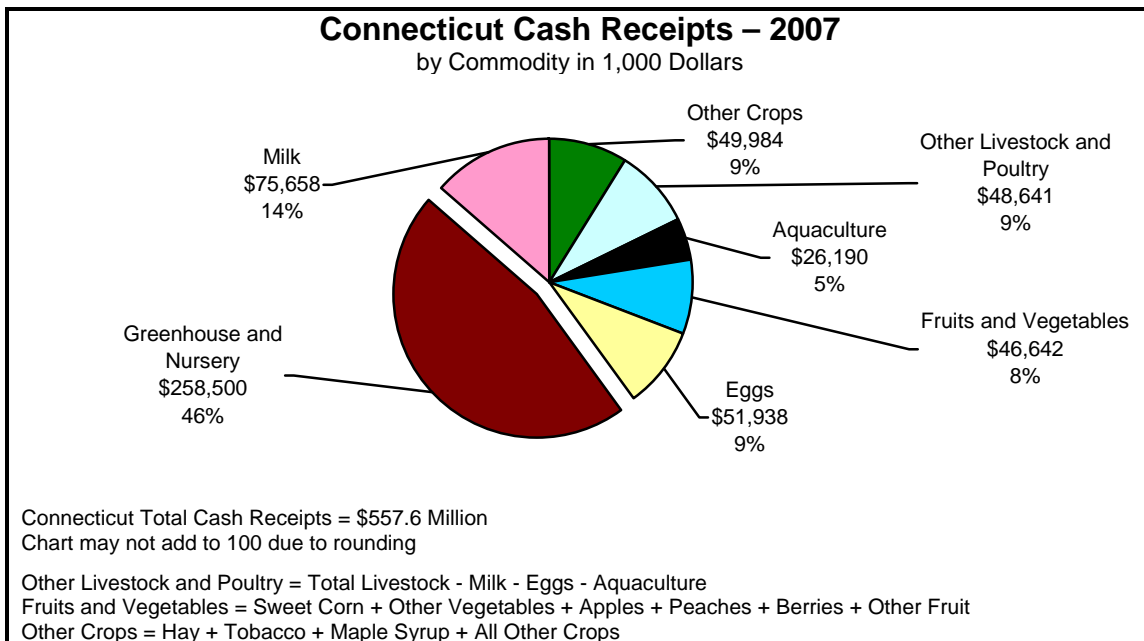

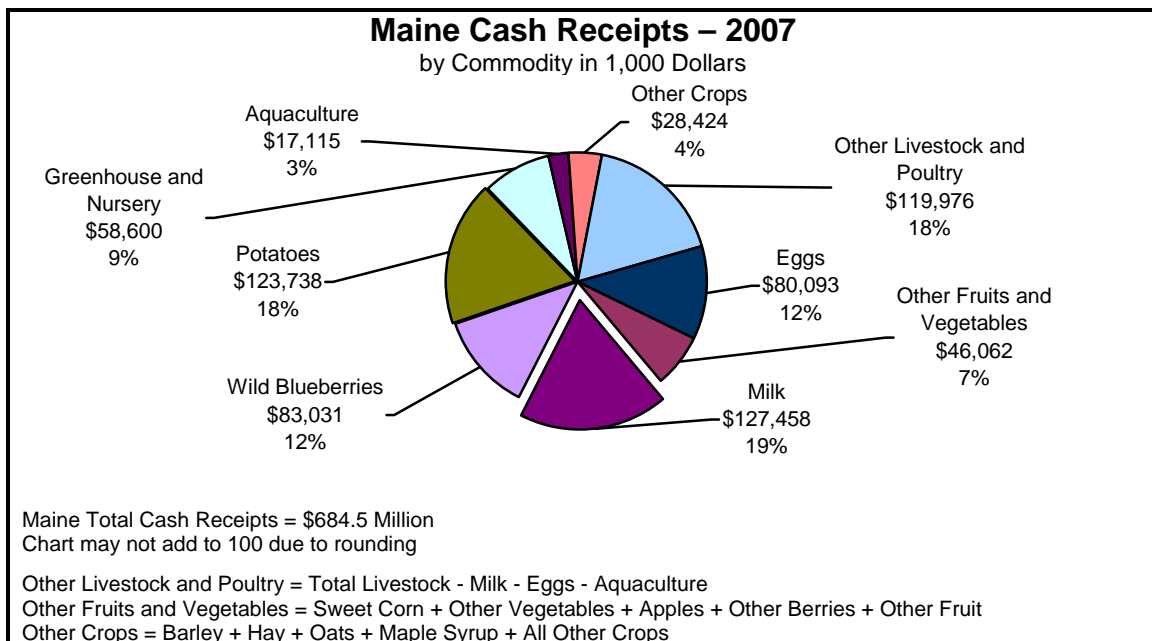
