Office of Science Implementation of Part D of the

Energy Employees Occupational Illness Compensation

Program Act of 2000

To assist in processing claims under the Energy Employees Occupational Illness Compensation Program Act of 2000 (EEOICPA), this memorandum delegates authority to the Office of Science (SC) Site Office Managers to sign "Letters of Determination" to SC contractors in regard to the provisions of Part D the EEOICPA, as outlined in the sample Notice of Positive Physician Panel Determination and Transmittal form (Attachment 1). These forms are currently sent to SC by the Office of Worker Advocacy (OWA) in the Office of Environment, Safety and Health (EH), but will be sent directly to you by OWA in the future.

The OWA has also requested that we provide points of contact at each site to obtain information for processing claims made under Part D the EEOICPA (Attachment 2). Please provide those points of contact to EH's OWA, and to Matt Cole at 301-903-8388, within 14 days of receiving this memorandum.

A special case exists for the Oak Ridge Reservation, due to the proximity of the three major sites located there, and the significant number of workers who worked for multiple employers in their careers. A process currently exists among the three major contractors on the Oak Ridge Reservation to establish responsibility for the EEOICPA claims, called the "Site Assignment Board." The Manager of the Oak Ridge Office should establish a single point of contact there who will work with the three DOE programs (SC, Office of Environmental Management, and National Nuclear Security Administration) at Oak Ridge and the contractors' Site Assignment Board to disposition the positive determinations and establish the responsible party.

Tracking the Progress of EEOICPA Part D Cases

I am writing to ask your office's assistance in connection with a project that the Office of Worker Advocacy (OWA) is developing in order to facilitate DOE's implementation of Part D of the Energy Employees Occupational Illness Compensation Program Act of 2000 (EEOICPA).

OWA is developing an information resource to enable us to track the progress of Part D cases from the point of affirmative Physician Panel (PP) finding to disposition of claims under state workers' compensation systems. Our objective is to complete a definitive information resource of workers' compensation coverage mechanisms for DOE contractor employees and the processes for payment of workers' compensation claims under those relationships, especially for those sites with the majority of Part D claims (Attachment 1). We are incorporating information already provided from your offices and the field into this information resource and we anticipate the need to contact the field to both verify existing information previously provided, and in some cases provide clarification of this information. We would appreciate it if, by April 9, 2004, you would identify a Point of Contact (POC) for each site in Attachment 1.

Once you have identified a POC for each site covered, we will be contacting them to help us collect the following information:

Prime contractor history over time (including construction and security services prime contracts where applicable);

History of workers' compensation coverage mechanisms for prime contractors; Copies of actual workers' compensation coverage mechanisms for each prime contractor; Best available information on the workers' compensation coverage mechanisms for subcontractors not covered under prime contractor workers' compensation mechanisms; and Claims payment process information. Ms. Judy Keating is the EH-8 point of contact for this initiative. Her telephone number is 202-586-7551. Working with Ms. Keating are Mr. Stuart Fribush and Mr. Joshua Stack.
