1. There have been no outbreaks of fowl plague (*highly pathogenic avian influenza*) during the last 2 years in the United States. When highly pathogenic avian influenza last occurred in the United States, an effective stamping-out policy was completed, as required by the Ministry of Agriculture and Forestry of Korea, which announced on September 3, 2004, in it's AHD-5112 that the avian influenza related prohibitions on US origin products were being removed.
2. There have been no outbreaks of velogenic Newcastle disease in the area where the birds for export of poultry meat were produced (*such an area being within radius of 10 kilometers from the production farm*) for the last two months.
3. There have been no outbreaks of fowl cholera, fowl typhoid, pullorum disease, infectious bursal disease, Marek's disease, duck viral enteritis, duck viral hepatitis, **Salmonella enteritidis** (*phage type 4*), Newcastle disease, and other serious infectious diseases of poultry as recognized by the United States for the last 12 months on the farm where the birds for export of poultry meat were produced.
4.
 - a. The product covered by this export certificate has been produced subject to the National Residue Program and meets FSIS maximum residue levels which are equivalent to those of the Korean government.
 - b. The poultry meat is produced under mandatory HACCP regulations that require testing for Salmonella, including Salmonella enteritidis (*phage type 4*), and is in full compliance.
 - c. The poultry meat has not been treated with ionizing, ultraviolet rays, tenderizers or other products likely to alter its nature or components
5. The packaging material used to wrap or pack the poultry meat is safe for the intended use within the meaning of section 409 of the Federal Food, Drug, and Cosmetic Act as amended. (*This s further described in Section 381.44 of the U.S. Mandatory Poultry Products Inspection Regulations.*)

**GUIDELINE FOR COMPLETION OF 9305-2A, CERTIFICATE FOR EXPORT OF POULTRY MEAT TO THE
REPUBLIC OF KOREA (ROK)**

Certificate Number

Block 1. Enter the certificate number from FSIS Form 9060-5. Replacement of FSIS Form 9305-2A is required if an "In Lieu of" certificate has been issued so that the number in this block matches the certificate number of the export certificate accompanying the consignment.

Plant Data

Block 2. Slaughter plant official name, address and Est. number must be entered for all poultry products.

Block 3. The boning or processing plant official name, address and Est. number must be entered for all poultry products. If poultry products are boned or processed at the slaughter plant, the information from block 2 should be repeated in this block.

Note: Official name (or official Doing Business As (DBA) name), address, and Est. number entries must exactly match the plant listing in the most current FSIS Meat and Poultry Inspection Directory or product will be detained by Korea. When a difference is determined, contact the FSIS Technical Service Center at (402) 221-7400. FSIS TSC may need to officially verify the change to Korean officials.

Slaughter and Pack/Processing Dates

Block 4. Slaughter dates are entered for all poultry products

Block 5. Packing or processing dates are entered for all poultry products

Note: The date ranges entered must cover all dates stamped on containers and processing/pack dates obviously cannot precede slaughter dates. Also, no date on product can precede the inauguration date of FSIS inspection at the plants involved. Errors regarding slaughter/pack dates may result in detained and possibly rejected shipments. FSIS personnel cannot provide assistance when this discrepancy is found.

Certification Location and Transport Information

Block 6 The City and State where the export is certified.

Block 7 The name of the vessel or flight number is entered.

Note: The City/State listed must match the "Exported From" block of FSIS Form 9060-5

FSIS Signature

Block 8. Printed first name, M.I., and surname of FSIS signing official

Block 9. Printed title or abbreviation (e.g., D.V.M.)

Block 10. Certifying official's signature

Note: The 9060-5 and 9305-3 must be signed by the same veterinarian.

Shipping Information

Blocks 11-16 Information provided and attested to by exporter/shipper.

Note: Block 14 is a commercial seal number, not a USDA seal. If errors are made in blocks 11-16, it will be necessary to obtain a replacement FSIS Form 9305-3 completed and signed by the FSIS certifying official - then the correction can be made to the exporter/ applicant blocks.
