### **LJUBISA BEARA**

DOB: July 14, 1939

POB: Sarajevo, Bosnia and Herzegovina

On March 26, 2002, the ICTY indicted Beara on one count of genocide or complicity in genocide, four counts of crimes against humanity (extermination; murder; persecutions on political, racial and religious grounds; and inhumane acts/ forcible transfer), and one count of murder as a violation of the laws or customs of war. Beara is currently in the custody of the ICTY.

**MIROSLAV BRALO**

AKA: Cicko  
DOB: October 13, 1967  
POB: Kratine, Vitez

On November 10, 1995, the ICYT indicted Bralo on nine counts of grave breaches of the Geneva Convention of 1949 (unlawful confinement of civilians, inhumane treatment, willful killing, torture or inhumane treatment); and 12 counts of violations of the laws or customs of war (outrage upon personal dignity, cruel treatment, murder, torture, outrages upon human dignity including rape). He is currently in the custody of the ICTY.

**VLASTIMIR DJORDJEVIC**

On October 2, 2003, the ICTY indicted Djordjevic on four counts of crimes against humanity (deportation; other inhuman acts (forcible transfer); murder; persecutions on political, racial and religious grounds) and one count of murder as a violation of the laws or customs of war.

**GORAN HADZIC**

DOB: September 7, 1958  
POB: Municipality of Vinkovci, Croatia

On June 4, 2002, the ICTY indicted Hadzic on eight counts of crimes against humanity (persecutions on political, racial and religious grounds; extermination; murder; imprisonment; torture; inhumane acts; deportation; inhumane acts / forcible transfers) and six counts of violations of the laws or customs of war (murder; torture; cruel treatment; wanton destruction of villages, or devastation not justified by military necessity; destruction or willful damage done to institutions dedicated to education or religion; plunder of public or private property).

**VLADIMIR LAZAREVIC**

DOB: March 23, 1949  
POB: Gricar

On October 2, 2003, the ICTY indicted Lazarevic on four counts of crimes against humanity (deportation; other inhumane acts (forcible transfer); murder; and persecutions on political, racial and religious grounds) and one count of murder as a violation of the laws or customs of war.

**SRETEN LUKIC**

DOB: March 28, 1955  
POB: Visegrad municipality, Bosnia and Herzegovina

On October 2, 2003, the ICTY indicted Lukic on four counts of crimes against humanity (deportation; other inhumane acts (forcible transfer); murder; and persecutions on political, racial, and religious grounds).
