LAST WEEK

BUDGET CONFERENCE HELD - The House and Senate held a Conference to resolve differences in House Resolution 83, the FY 2002 budget outline. Conferees discussed the need to reach consensus, although no votes were taken. Sen. Grassley (IA) stated the need for more funding for agriculture and conservation as indicated in the Senate passed amendments. The conference ended with no schedule set to present the final bill. The budget resolution is non-binding that sets funding levels for several Committees, primarily appropriations.

SENATE AND HOUSE HEARINGS ON FY 2002 AGRICULTURE

APPROPRIATIONS – The Senate and House held hearings on FY 2002 Agriculture Appropriations. Secretary of Agriculture, Ann M. Veneman, presented testimony and responded to questions in both hearings.

The Senate Appropriations Subcommittee on Agriculture (Chairman Cochran-MS) hearing was held on April 25, 2001. Sen. Richard Durbin (IL) questioned the elimination of WRP, WHIP, EQIP and CRP in the President's budget. USDA Budget Officer, Steve Dewhurst pointed out that WRP would reach the authorized 1,075,000 acres limit this year and that FPP and WHIP had already reached authorized funding limits. The Secretary noted eminent reauthorization of the farm bill and said that conservation would be an important part of the legislation.

The House Appropriations Subcommittee on Agriculture (Chairman Bonilla-TX) held a hearing on April 26. Rep. Jack Kingston (GA) stated an interest in how well conservation programs such as CRP, WRP, WHIP, EQIP are working. He requested an update in writing be provided.

HOUSE BRIEFING ON GULF OF MEXICO HYPOXIA- On Monday, April 23, a briefing was held for House and Senate staff regarding the impact of nitrogen on hypoxia in the Gulf of Mexico. The meeting was sponsored by the Upper Mississippi River Congressional Task Force. The Mississippi River / Gulf of Mexico Nutrient Task Force presented the results of the integrated assessment and proposed Action Plan. The Action Plan outlines a goal to reduce nitrogen discharges into the Gulf by 30% by 2015. Among the key indicators used to monitor progress includes producers/acres enrolled in WRP and CRP, projects funded through EQIP, vegetated buffers along rivers and streams in

priority watersheds, and acres in conservation tillage. Many key staff from House and Senate offices as well as Committee staff attended the meeting.
