LAST WEEK:

AGRICULTURE ASSISTANCE - On August 3, the Senate passed the House version of the Agriculture Assistance bill (H.R. 2213) by voice vote. The House version provides payment to producers, but does not contain funding for conservation programs.

SENATE CONSERVATION HEARING – The Senate Committee on Agriculture, Nutrition, and Forestry held a hearing on conservation issues, with an emphasis on working agricultural lands. Witnesses included representatives from conservation and environmental organizations such as the National Corn Growers Association, American Soybean Association, USA Rice Federation, National Association of Conservation Districts, Land Stewardship Project, Soil and Water Conservation Society and Defenders of Wildlife. Gary Mast of the National Association of Conservation Districts presented the Committee with NACD's recommendations for the next farm. George Dunklin, Jr. a rice farmer from Arkansas and representing the U.S. Rice Producers Groups remarked that conservation programs can provide for important societal benefits in the form of clean water, air, forest conservation, improved wildlife habitat and species preservation. Dave Serfling of Land Stewardship Project asked the committee to consider stewardship incentives that promote conservation on working lands. He also urged the committee to extend conservation compliance into the new farm bill and apply it to all federal subsidy programs.
