SENATE CONFIRMATION OF CABINET-On Tuesday, January 30, 2001 Gale Norton was confirmed as the Secretary of Interior by a vote of 75-24. Christine Todd-Whitman was confirmed as Administrator of EPA by a vote of 99-0.

SENATE OVERSIGHT HEARING – The Commission on 21 st Century Production Agriculture (the Commission) presented the findings of its final report to the Senate Committee on Agriculture, Nutrition, and Forestry (Chairman- Sen. Richard Lugar, R-IN) on Jan. 30, 2001. Keith Collins, USDA Chief Economist, and Dr. Barry Flinchbaugh, chair of the Commission, presented testimony. Dr. Flinchbaugh also gave a final report to the House Committee on Agriculture (Chairman-Rep. Larry Combest, R-TX) on Jan. 31, 2001. Other members of the Commission were present at both hearings to respond to questions from Committee members.

The Commission recommended continuing income support payments and to add new payments. They recommended continuation of the Conservation Reserve Program and to emphasize the buffers, filter strips, and field inclusions through a continuous signup program. They recommended full authorization of the EQIP program and to provide NRCS adequate funding for technical assistance to implement the program.

Questions related to conservation came from several Senators. Sen. Cochran (R-MS) asked whether the Commission considered WRP and WHIP. Commission member John Campbell (Nebraska) strongly endorsed the Conservation Security Program concept as an excellent way to provide income to all farmers that was de-coupled from market distortion, a priority of the Commission's recommendations.

Sen. Lugar (R-IN) was supportive of the Commission's recommendations on small and limited resource farmers, supporting Commission member Ralph Paige's (Georgia) efforts to help black farmers. Sen. Lugar emphasized that outreach efforts are needed to address this issue.
