## LAST WEEK:

**FY 2002 AGRICULTURE APPROPRIATIONS BILL** - On Wednesday, July 11, 2001, the House of Representatives passed the Agriculture Appropriations Bill for FY 2002, H. R. 2330. The vote was 414 Yeas, 16 Nays, and two members did not vote.

A summary of reported funding for NRCS is as follows:

Two amendments were approved during floor debate on the bill that directly impact NRCS. The first was by Rep. Lucas (OK) to add \$5.4 million to the Watershed and Flood Prevention Operations program to rehabilitate aging watershed infrastructure. The second amendment was by Rep. Hinchey (NY) that prohibits eliminating positions related to the American Heritage Rivers Initiative.

**2001 SUPPLEMENTAL APPROPRIATIONS ACT -** The Senate passed the 2001 Supplemental Appropriations Act, H. R. 2216, and included an additional amount of

\$5 million for Watershed and Flood Prevention Operations to repair damages to waterways and watersheds, resulting from natural disasters occurring in West Virginia on July 7 and July 8, 2001.

**SENATE AGRICULTURE HEARING** – The Senate Agriculture, Nutrition, and Forestry Committee held a hearing on July 12, 2001 on the framework of the next farm bill. Witnesses represented various commodity groups such as corn, soybeans, and sorghum. Testimony focused on the importance of providing a safety net for farm producers. Many of the member's questions related to the importance of land conservation programs. Witnesses agreed that a conservation was very important and should be part of a comprehensive strategy to boost farm income and sustain production.

**DEPARTMENT OF AGRICULTURE CONFIRMATIONS** - On Thursday, July 12, the Senate Agriculture, Nutrition and Forestry Committee (Chairman Harkin, IA) held a confirmation hearing on pending nominations of James R. Moseley to be Deputy Secretary of Agriculture and Joseph J. Jen to be Under Secretary of Agriculture for Research, Education and Economics. Members of the Committee asked nominees to provide feedback on a variety of issues. Dr. Jen spoke of agriculture education, food safety and enhancement of agricultural research. Mr. Moseley spoke of taking leadership to increase resources, and enhance GIS technology, soil quality and water quality. The nominees were reported out of Committee and were successfully confirmed by the U.S. Senate on Thursday evening.
