## LAST WEEK:

**HOUSE FARM BILL FULL COMMITTEE MARKUP** – The House Agriculture Committee (Chairman Combest, TX) approved a 10-year, \$73.5 billion farm bill (HR 2646) on Friday July 27, 2001. The legislation authorizes many USDA Conservation programs through 2011.

**SENATE AGRICULTURE HEARING** - On July 24, 2001, the Senate Agriculture, Nutrition, and Forestry Committee (Chairman Harkin, IA) held a hearing on livestock issues and the farm bill reauthorization. Witnesses represented several livestock groups and sustainable agriculture organizations. All witnesses spoke favorably about the focus on conservation and offered suggested improvements to specific programs such as EQIP and WHIP. Both the National Pork Producers and the Sustainable Agriculture Coalition supported the proposed Conservation Security Program and the draft conservation title to the next farm bill that Sen. Lugar is circulating.

FY 2001 EMERGENCY AGRICULTURE ASSISTANCE AUTHORIZATION - On Wednesday, July 25, 2001, the Senate Agriculture Committee (Chairman Harkin, IA) reported S. 1246, Emergency Agriculture Assistance Bill for FY 2001. The bill provides emergency funding to assist with crop losses. The legislation includes funding several conservation programs. These include EQIP - \$250 million, WRP-\$200 million, FPP-\$40 million, WHIP- \$7 million, and EWP-\$10 million for floodplain easements. There is also a \$44 million for technical assistance to assist CRP. The next step is for the full Senate to consider the legislation.

HOUSE AGRICULTURE BRIEFING - Carole Jett, Associate Deputy Chief of Programs, Mark Berkland, Director of Conservation Operations, Lee Bensey, Director of Watersheds and Wetlands and NRCS legislative affairs staff met with staff from the office of Rep. Tim Holden (D-PA) to discuss conservation programs. Rep. Holden is the new ranking member of the Subcommittee on Conservation, Credit, Rural Development and Research of the House Agriculture Committee.

AGRICULTURE NOMINATIONS CONFIRMATION HEARING - The Senate Agriculture, Nutrition and Forestry Committee (Chairman Harkin, IA) held a confirmation hearing on pending nominations on July 26, Nominations: Mark Edward Rey to be Under Secretary of Agriculture for Natural Resources and Environment and to be a member of the Board of Directors of the Commodity Credit and Corporation and Hilda Gray Legg to be administrator for the Rural Utilities Service, Department of Agriculture.

ILLINOIS RIVER 2020 BRIEFING – On Tuesday, July 24, 2001, Acting Deputy Under Secretary for Natural Resources and Environment, Dr. R. Mack Gray; USDA Assistant Secretary for Congressional Relations, Mary Waters; and NRCS staff attended a meeting with representatives of the Illinois Congressional Delegation, and State Government officials on the Illinois River Basin 2020 program. Governor Ryan and Lt. Governor Corinne Wood have initiated the Illinois Rivers 20/20 restoration program, which would build upon CREP efforts in the basin. The voluntary program would offer additional incentive-based solutions to protect the river and its tributaries over the next 20 years, and utilize many existing Federal Farm Policy Legislation programs and State conservation programs. Senator Richard Durbin and Representative Ray LaHood have led the effort and attended the meeting along with Rep. John Shimkus and Rep. Jerry Weller. Meeting participants discussed the health of the Illinois River watershed and the potential benefits the initiative will provide. Both state government officials and Congressional Members stressed the importance of USDA conservation programs and voluntary assistance. The delegation requested ideas on how to proceed with the

initiative and also what resource needs were present in the basin. Dr. Gray expressed support for the Illinois River 2020 program, and applauded federal and state collaboration as a way of maximizing benefits of conservation funding.
