**2008 No Spray Request and
Property Owner/King County
Maintenance Agreement**

As a property owner in King County, I understand King County will provide a 2008 Herbicide Vegetation Control Program to discourage undesirable brush growth, noxious weeds and grass along the roadway shoulder.

I, _____, understand if I request the County NOT to spray adjacent to my property in 2008, then it becomes my responsibility to maintain the vegetation along said road right-of-way. I further understand if I do not maintain the vegetation, this agreement becomes null and void and said right-of-way will be returned to the Herbicide Vegetation Control Program.

Please Read and Check

_____ I request King County delete spray at the location indicated below.

_____ I agree to post "**Owner Will Maintain**" signs on the borders of my property so they are clearly visible from the driving lane on the side of the street closest to the property. I understand if I do not properly place the signs so they are clearly visible, and readable (by the truck driver of the application vehicle) then the County may, without prior notice, treat the described area.

_____ I agree to periodically inspect the signs for visibility and proper sign placement, and replace if needed.

_____ I agree to control undesirable vegetation, including alder, willow, blackberry, tansy ragwort, and other noxious weeds, within the road right-of-way so traffic visibility is not hindered and the vegetation does not encroach into the roadway surface.

_____ I hereby accept the responsibility for installation and maintenance of the "Owner Will Maintain" signs in the manner and at the location as set forth in this agreement. I further agree my performance under this agreement is at my sole risk and I shall indemnify King County, its agents and employees, and hold them harmless from any and all liability for damage, costs, and expenses resulting from, arising out of, or in any way connected with this agreement, or from my failure to perform fully there under. I further agree to defend King County, its agents and employees, against all suits, actions, or proceedings brought by any third party against them for which I would be liable there under.

_____ I understand this agreement is not transferable and is valid only for the calendar year in which it was signed. So, this agreement must be signed and returned to the given King County address each year in order for it to be in effect.
