



Contractors awarded on the TSS Schedule have been pre-qualified to deliver expert services to you. Services available under the following Special Item Numbers (SINs) include:

### **599-1 Travel Consulting Services**

Professional advice and/or information on travel-related matters to assist with meeting travel needs for temporary duty (TDY) travel, and/or temporary/permanent change of station/relocation. A few of the available services include:

- Developing strategies for adoption of the eTravel Service (eTS) or the Defense Travel System (DTS)
- Identifying travel security needs
- Re-engineering business processes
- Developing travel policy
- Developing customer satisfaction surveys, assessments and analyses
- Studying current travel management processes and recommending efficiencies
- Analyzing travel card data to facilitate travel management

- Re-engineering relocation processes
- Testing technologies
- Evaluating proposals, services, contractor performance, and products
- Providing trend analysis of agency travel spending to enable budget forecasting or potential cost savings

### **599-2 Travel Agent Services**
