Board adds three new members

Dr. Donald Girard of Portland, Dr. Linda Johnson of Turner, and Dr. Ralph Yates of Portland began their service to the Oregon Medical Board earlier this year.

The Oregon Medical Board recently welcomed Donald E. Girard, ▲ MD, Linda B. Johnson, MD, and Ralph A. Yates, DO to the board. Drs. Johnson and Yates will serve three year terms, and Dr. Girard will fill an unexpired term ending in 2010. The new members were appointed by Governor Kulongoski and confirmed by the Oregon Senate.

Dr. Girard is a Professor of Medicine and Associate Dean for Graduate and Continuing Medical Education at Oregon Health & Science University School of Medicine. He has served on the OHSU faculty since 1975 and is engaged in patient care, teaching and academic pursuits.

Dr. Girard has also participated in professional organizations at the state and national levels. He is past president of the Medical Society of

techMed to the rescue!

In January 2006, the Oregon Medical Board (OMB) began a complete overhaul of its database systems to ensure that the Board continues to complete licensing and renewal of licenses in a timely manner, investigates complaints that appear to be in violation of the Medical Practice Act, and monitors licensees under disciplinary action or probation.

The current system is more than 15 years old and is inadequate for case management activities. It also is unable to meet applicant, licensee and other customer expectations for services, such as online processing and payment for license renewals.

In April 2008, the Board signed a contract with GL Suite (GLS), a company from Bend, to create a system that will meet the above expectations and more. Board staff has worked tirelessly

with GLS to create a clear vision of what is needed to efficiently manage cases and process licenses and renewal applications, along with bringing more convenience to the process by adding additional online options.

The estimated completion date is March 2009. At that time, the



OMB will have a unified system that will allow Licensing and Investigations to work in a more cohesive manner and provide more fluidity between all OMB departments, while increasing our customer service levels and providing more opportunities for convenience. •

Metropolitan Portland, and is a past member of the Oregon Medical Association Executive Committee. FAQs from the OMB

nce a month, four physicians and one public member of the Board meet for a full day to review complaints and investigations. The Investigative Committee, as it is called, makes recommendations to the Full Board. In an effort to clarify certain issues that have come up through the Investigative Committee, the OMB is offering some answers to frequently asked questions.

If you have other questions or issues you would like addressed, please contact the OMB and we would be happy to tackle the question in a future issue of the newsletter. Email us at omb.info@state.or.us or call us at (877) 254-6263.

- Q. "Do I have to report a DUII conviction to the OMB?"
- A. Yes, within 10 days.
- **Q.** "May I prescribe medication to my spouse or family member when her/his physician is unavailable?"
- A. Yes, IF
 - You don't make it a habit, AND
 - You evaluate and chart your workup of her/ him just like any other patient, AND
 - It's not for a scheduled drug.
- **Q.** "May I prescribe medication for myself when my physician is unavailable?"
- A. Remember the old adage: "The physician who treats him/herself has a fool for a patient." Also keep in mind that it is not uncommon for pharmacies to call the OMB on these issues...

- Q. "Our group just moved into a different office.

 Do I need to report the change of address to the OMB?"
- **A.** Yes, within 30 days.
- Q. "My P.A., who previously was granted privileges by the Board to do spinal taps, has gotten really good at doing them. Do I have to be right there when he/she does them?"
- **A.** That would depend on the type of supervision originally put in place.
 - If your Physician/PA authorization from the OMB says "Personal Supervision," you have to be standing next to him or her during the procedure.
 - If your authorization says "Direct Supervision," you must be in the same building and able to help out within minutes.
 - If your authorization says "General Supervision," you do not need to be in the building, but you need to be available by telephone.

Changes to privileges are requested through and approved by the Physician Assistant Program at OMB. Remember, in all cases, you are personally responsible for everything your PA does.

- **Q.** "How long do I have to wait after discharging a patient before I can date him/her?"
- **A.** This is one of the tougher questions to answer, but the following are some general guidelines from which to start.
 - If you're a psychiatrist: Forever. You may never date your patient.

OHSU Program Returns Physicians to the Work Force

regon Health & Science University may be a one-of-a-kind innovator nationally by realizing that returning previously trained doctors to the work force is a more efficient, economical approach to the physician shortage than training new graduates.

That's the theme behind OHSU's Physician Reentry Program which was created to help address the state's need for doctors. The program takes its cue from Oregon Medical Board figures showing that approximately 1,000 doctors leave practice every two years.

An estimated several hundred physicians among that group have allowed their licenses to lapse. That number provides a potential pool of physicians who could become active again in patient care if they had the opportunity to refresh and update their knowledge and skills.

Some have let their licenses expire without realizing it, left practice for health or family reasons, or decided to return to practice after working in administrative medicine or research, or as a volunteer, said Elizabeth A. Bower, MD, assistant dean for continuing medical education and chairwoman of the retraining program.

Many doctors don't realize that if they do not practice for two years, they lose their license under Oregon law, she explained. To re-enter practice, they are required to undergo retraining.

Richard Allen, MD, former assistant dean for graduate medical education, came up with the idea and thought the opportunity was there to help bolster the number of practicing physicians, said Donald E. Girard, MD, associate dean for graduate and continuing medical education in the OHSU School of Medicine. "Dick brought this forward, and it worked," he said.

Girard and Allen, each a past president of the Medical Society of Metropolitan Portland, worked with other area medical educators and the Oregon Medical Board to launch a pilot program in 2006. The Physician Re-entry Program now is managed by the School of Medicine's continuing medical education division.

The program has retrained and added seven physicians to the Oregon work force so far: three obstetrician-gynecologists, one internist-rheumatologist, one pediatric endocrinologist, one pediatrician and one family physician. Graduates include two men and five women, ranging in age from 40 to 65 years. All but one now is practicing in rural areas around Oregon.

GROSSMAN, Charles Milton MD; MD03972 Portland, Ore.

Licensee entered into an Interim Stipulated Order with the Board on February 1, 2008. In this Order Licensee agreed not to prescribe benzodiazepines (Schedule IV) to patients whose treatment includes opioid therapy or patients who are reasonably suspected to be illegally using controlled substances or "street" drugs. MCCLUSKEY, Edward Alan, MD; MD18356 Gresham, Ore.

Licensee entered into a Stipulated Order with the Board on April 11, 2008. In this Order Licensee agreed to the following terms and conditions: 10 years probation with quarterly reports to the Board; reprimand; complete the Physician's Evaluation Education and Renewal Program (PEER) of the Oregon Medical Association within 24 months; course on medical ethics; Licensee may not supervise more than two physician assistants (PAs) at any one time and PAs must have documented post-graduate training or work experience in chronic pain management.

MITCHELL, Frederick Lee, MD; MD21015 Newberg, Ore.

Licensee entered into a Stipulated Order with the Board on April 11, 2008. In this Order Licensee surrendered his Oregon medical license while under investigation and agreed not to reapply for an Oregon medical License for a minimum of two years.

probation; reprimanded; fined \$2,500; Licensee must complete the Physicians Evaluation, Education, and Renewal (PEER) program of the Oregon Medical Association within 24 months; Licensee shall not prescribe controlled substances (Schedule II's & III's) in excess of seven days for patients suffering from acute pain; Licensee must refer all of his patients suffering from chronic pain to other physicians for treatment of their chronic pain; and Licensee's practice is subject to no-notice inspections by Board staff to ensure compliance.

Voluntary Limitations

Voluntary Limitations are not disciplinary actions, but are reported to the National Practitioner Data Bank (NPDB).

STUBBS, Ervin Gene, MD; MD07745 Oregon City, Ore.

Licensee entered into a Voluntary Limitation with the Board on March 6, 2008. In this Order the Board agreed to reactivate Licensee's Oregon medical license under the condition that he limit his practice to clinical autism research only. This Order is not a disciplinary action.

Corrective Action Orders

Corrective Action Orders are not disciplinary actions, but are public orders issued with the goal of remediating problems in licensees' individual practices. They are not reported to the National Practitioner Data Bank (NPDB).

Licensee entered into a Corrective Action Order with the Board on December 6, 2007.

In this Order, Licensee agreed to complete the Physicians Evaluation, Education and Renewal Program (PEER), complete a course on documentation, and will only perform thyroidectomies with an assistant who has experience in thyroid surgery. This Order is not a disciplinary action.

MASLONA, Andrew Rowe, MD; MD28259 Coos Bay, Ore.

Licensee entered into a Corrective Action Order with the Board on April 16, 2008. In this Order, Licensee agreed to remain in good standing with the Health Professionals Program and to obtain a practice mentor who shall provide quarterly progress reports to the Board. Licensee will provide a copy of this Order to the Medical Director of any health care facility where he is employed or where he provides medical care to patients. This is not a disciplinary action.

- Other physicians: "A significant period of time." This is open to some interpretation, but this observer would suggest that a minimum of one year is appropriate.

Why are these guidelines so strict? Because the authoritarian power of a physician is greater than you think. The physician is in a dominant,

powerful and influential position relative to the patient, and that distorts the equation against the patient. You are privy to personal information about the patient which places him/her at a disadvantage. •

One of those, Ed Shapiro, MD, an obstetrician and gynecologist and the program's first graduate, practiced medicine for 20 years. Then he retired to Port Townsend, Wash.

"But it wasn't long before I was missing the action," he said. "Nothing really pulled at my heartstrings anymore. After four years I decided it was time to return to my chosen profession and do more with my life."

Shapiro continued reading professional journals and started working locum tenens. He kept up his Idaho and Washington medical licenses and considered practicing in Oregon, but Oregon's requirements meant he would need to undergo retraining before he could apply for that state's license.

After hearing about OHSU's program, he contacted Allen. The OHSU graduate medical education and obstetrics and gynecology departments fashioned a re-entry program tailored to his specific needs and specialty.

"I did the same clinical rotations as residents," said Shapiro. "It was the training experience I needed. I didn't need to take any classes. I was current in my knowledge, but I did need to rotate on the OB unit for high-risk pregnancies and C-sections, and in surgery scrubbing-in on Gyn cases."

"We individualize it for everyone," Girard said of the re-entry program. Duration of an individual's retraining has averaged two to three months so far, depending on physicians' current knowledge base and whether surgical skills are involved. Each retraining physician is appointed a fellow in graduate medical education at OHSU.

Physician applicants must be in good standing and have no disciplinary restrictions.

Costs to the doctor—or the recruiting hospital, if a hospital is willing to pay part or all of the expenses—have ranged from \$3,000 to \$10,000 a month, although that figure could vary depending on the individual's situation, according to Girard. "The more complex the training, the higher the cost," he said. The non-refundable fee to apply is \$1,500.

"As far as we know, we are the only real reentry program in the country," in terms of providing hands-on clinical experience in the retraining of former practicing physicians, said Girard. "A lot of people are looking for this, but very few (medical schools) are offering it."

Shapiro now is working full-time at Mountain View Hospital in Madras. "I am thankful that OHSU is willing to provide this opportunity for me and other physicians who want to return to their profession, and to help out with this growing shortage of doctors," he said.
