ASHBY, WILLIAM EDWARD, MD; MD08822; WALLA WALLA, WA

The Board issued a Default Final Order on January 15, 2004. The Board placed Licensee on five years of probation to include a reprimand, fine, and quarterly Board reporting.

BOGART, LARRY FRANK, MD; MD20341; Roseburg, OR

Licensee entered into a Stipulated Order with the Board on October 14, 2004. In this Order Licensee was reprimanded; restricted from treating coworkers/family/friends; Licensee may not prescribe nor approve use of any Schedule I-III controlled substances; Licensee may not treat patients under the age of 18 years old; Licensee must complete CME on boundaries and appropriate prescribing; and quarterly board reporting.

BORMAN, Nancy Lynne, DO; DO19719; Vancouver, WA

Licensee entered into a Corrective Action Order with the Board on September 2, 2004. In this Order Licensee agreed to remain under the care of a psychiatrist who shall submit quarterly reports to the Board; shall abstain from alcohol; and shall submit to random UA's.

CAHN, PAUL JEFFREY, MD; MD19037; BEAVERTON, OR

On July 9, 2004 Licensee entered into a Stipulated Order with the Board. In this Order Licensee agreed to the following terms: probation, reprimand, fine, no clinical supervision of PA's, Complete PEER, documentation course, quarterly Board reporting, provide hospital/clinic administrators with copy of order.

CALHOUN, JAMES MICHAEL, MD; MD17171; LITTLE ROCK, AR

Licensee entered into a Stipulated Order on January 15, 2004. In this Order Licensee agreed to surrender his Oregon medical license while under investigation.

CLINKINGBEARD, Cynthia Lou, MD; MD25344; Boise, ID

On July 9, 2004, Applicant entered into a Stipulated Order with the Board. This Order granted Applicant an Oregon medical license under the following conditions: no solo practice in a practice setting approved by the Board, must remain under the care of a physician and psychiatrist who shall submit quarterly reports to the Board, must provide care providers with copy of the order, Applicant and her health care providers must notify Board if there are any changes in condition which would adversely affect her ability to practice.

DIERDORFF, John Terence, DO; DO06866; Hillsboro, OR

Licensee entered into an Amended Interim Stipulated Order with the Board on August 5, 2004. This Order modified Licensee previous Interim Stipulated Order dated May 6, 2004 and requires Licensee to participate in psychotherapy; have a chaperone for female patients over the age of 12; and prohibits Licensee from dating or having romantic contact with current or former patients seen by Licensee within the last six months.

Licensee entered into an Interim Stipulated Order with the Board on May 6, 2004. In this Order Licensee agreed to use chaperones when examining or treating female patients and agreed not to engage in a dating or sexual relationship with any current patient or former patient that Licensee has treated within the past 6 months. This Order remains in effect until the conclusion of the Board's on-going investigation regarding allegations of sexual boundary violations with female patients.

DUBIN, David Alexander, MD; MD25083; PORTLAND, OR

On April 15, 2004 Licensee entered into a Voluntary Limitation with the Board. In this Order Licensee voluntarily limited his practice to occupational medicine, to include independent medical examinations. Licensee's practice sites must be pre-approved by the Board. Licensee must complete coursework in occupational medicine and have a practice mentor who shall submit quarterly reports to the Board.

ELLIOTT, ROBERT MICHAEL, MD; MD18653; NEWPORT BEACH, CA

Licensee entered into a Stipulated Order with the Board on May 6, 2004. In this Order Licensee agreed to surrender his Oregon medical license while under investigation.

ELLISON, ELIZABETH LEIGH, MD; MD22018; CHARLOTTE, NC

Licensee entered into a Stipulated Order with the Board on October 14, 2004 in which she agreed to surrender her Oregon medical license while under investigation. Licensee also agreed to never re-apply for licensure in Oregon.

ELLISON, MELANIE ANNE, MD; MD19066; STEAMBOAT SPRINGS, CO

Licensee entered into a Stipulated Order with the Board on September 2, 2004. In this Order Licensee agreed to surrender her medical license while under investigation.

FARRIS, CATHLEEN LYNN, MD; MD19029; CAMAS, WA

On April 1, 2004 Licensee signed an Interim Stipulated Order in which she agreed to withdraw from practice pending the conclusion of the Board's investigation into allegations of substance abuse and violation of a Board Order. The Board approved this Order on April 15, 2004.

FAULK, CHARLES EDWARD, MD; MD10505; SALEM, OR

On March 4, 2004, the Board issued an Order Terminating Interim Stipulated Order. This order returns Licensee back to practice by terminating the August 7, 2003 Interim Stipulated Order in which Licensee had agreed to withdraw from practice.

FREEMAN, DALE OWENS, AC; AC00213; SHERIDAN, OR

On July 9, 2004, Licensee entered into an Interim Stipulated Order with the Board which prohibits Licensee from treating female patients, requires that he use appropriate draping/gowns for all patients, and requires that he maintain accurate and up-to-date charts. This Order will remain in effect until the conclusion of the Board's on-going investigation into allegations of inappropriate treatment/touching.

GINSBURG, MARVIN LEONARD, MD; MD20864; CANYONVILLE, OR

Licensee entered into a Stipulated Order with the Board on May 6, 2004 with the following terms: reprimand, fine, Licensee must obtain additional training before he can perform colonoscopies, to include sigmoidoscopy, or upper gastrointestinal endoscopic procedures.

KELLER, Erik Johan, MD; MD20864; Portland, OR

On July 9, 2004, Applicant entered into a Stipulated Order with the Board. In this Order, Applicant agreed to withdraw his Oregon acupuncture application while under investigation.

LAURY, DANIEL HENRI, MD; MD17823; Medford, OR

Licensee entered into a Corrective Action Order on January 15, 2004. In this Order Licensee agreed to obtain Board approval prior to resuming the practice of obstetric medicine; work with a physician mentor; continue treatment with a mental health provider; maintain appropriate professional conduct; hysterectomy procedures to be reviewed; cross coverage by a physician. ORDER MODIFIED 7/04: Term 3.3 requiring mental health provider was terminated. ORDER MODIFIED 1/05: Term 3.5 requiring review of hysterectomy procedures was terminated.

LEE, ANTHONY HYUNBO, MD; MD15438; BEAVERTON, OR

On April 15, 2004 Licensee entered into a Corrective Action Order with the Board. In this Order Licensee agreed to complete coursework pre-approved by the Board regarding appropriate prescribing and pain management.

LEE, CAROL FROST, MD; MD12002; BEND, OR

On April 14, 2004 Licensee entered into a Corrective Action Order with the Board. In this Order Licensee agreed to complete coursework in internal medicine and practice with a practice monitor who will conduct monthly chart review for one year.

LEVEQUE, PHILLIP EDWIN, DO; DO10919; MOLALLA, OR

On March 4, 2004, the Board approved the emergency suspension of Licensee's Oregon medical license. The Board took this action based on its immediate concerns regarding the safety and welfare of Licensee's current and future patients.

The Board issued a Final Order on October 15, 2004. This Order revoked Licensee's Oregon medical license and imposed contested case hearing costs as well as a fine of \$5,000.

The Board issued an Order Denying Motion for Stay of Emergency Suspension on May 6, 2004. This Order denied Licensee's request to stay the Board's Order of Emergency Suspension dated March 12, 2004.

LEVY, JONATHAN SANDLER, MD; MD08928; PORTLAND, OR

Licensee entered into a Stipulated Order with the Board on October 14, 2004. In this Order Licensee agreed to surrender his Oregon medical license while under investigation. Licensee also agreed to never re-apply for licensure in Oregon.

LITTELL, NED GILES, MD; MD16406; LONGVIEW, WA

On July 9, 2004, Licensee entered into a Stipulated Order with the Board in which he agreed to surrender his Oregon medical license while under investigation.

LIVINGSTON, MARK DAVID, MD; MD20675; St Helens, OR

On April 15, 2004 Licensee entered into a Corrective Action Order with the Board of Medical Examiners. In this Order Licensee agreed to keep his medical charts updated to include timely posting of lab reports, have a practice monitor who will meet with Licensee at least monthly to review Licensee's practice, including chart reviews.

LOGAN, Jacqueline Susan, MD; MD20914; Salem, OR

On July 9, 2004, Licensee entered into a Stipulated Order with the Board. In this Order Licensee agreed to the following terms: reprimand, may not prescribe controlled substances, may not work more than 32 hours per week, practice setting must be pre-approved by Board, enroll in Health Professionals Program (HPP).

MALETZKY, BARRY MICHAEL, MD; MD07737; PORTLAND, OR

Licensee entered into a Stipulated Order with the Board on May 5, 2004. In this Order Licensee surrendered his Oregon medical license while under investigation.

MEAD, RICHARD JOSEPH, MD; MD11683; SALEM, OR

Licensee entered into a Stipulated Order with the Board on January 15, 2004. This Order placed Licensee on 10-years of probation with the following terms: reprimand; compliance with the practice and educational recommendations recommended by the Center for Personalized Education for Physicians (CPEP); quarterly Board reporting.

MOORE, Lois Ann, MD; MD25350; BAKER CITY, OR

Licensee entered into a Voluntary Limitation with the Board on August 5, 2004. This Order limits Licensee's practice to radiology.

MOOS, STEVEN GABRIEL, MD; MD20201; TIGARD, OR

On July 9, 2004, the Board issued a Final Order by Default which revoked Licensee's Oregon medical license; imposed a \$5,000 fine; reprimand; and assessed costs related to his April 21, 2004 Contested Case Hearing.

NEILSON, JOHN TUCKER, MD; MD14328; ASTORIA, OR

On April 15, 2004 Licensee entered into a Stipulated Order with the Board. In this Order Licensee agreed to retire his Oregon medical license while under investigation regarding Board findings that Licensee engaged in unprofessional conduct, gross or repeated acts of negligence, and prescribing controlled substances without legitimate medical purpose.

NEITLING, Stanley Joseph, MD; MD13059; Tillamook, OR

Licensee entered into an Interim Stipulated Order with the Board on September 2, 2004. In this Order, Licensee agreed to withdraw from practice pending the conclusion of the Board's investigation regarding his competency to practice medicine.

PRICE, Leonard Atkinson, MD; MD13059; Santa Barbara, CA

On April 15, 2004 the Board issued a Final Order by Default which denied Applicant's application for Oregon medical licensure.

RIPPLINGER, Joseph John, AC; AC00626; GRESHAM, OR

On July 9, 2004, Licensee entered into an Interim Stipulated Order. In this Order, Licensee agreed not to treat female patients and to respect patient autonomy and boundaries pending the conclusion of the Board's on-going investigation regarding allegations of professional boundary violations.

On July 9, 2004, Licensee entered into a Stipulated Order with the Board. In this Order Licensee agreed to the following terms: reprimand, fine, must complete a self-study course on proper billing, semi-annual chart audit.

SIDDALL, DONLEY DEE, MD; MD09309; COLLEGEDALE, TN

Licensee entered into a Stipulated Order with the Board on September 2, 2004. In this this Order, Licensee voluntarily surrendered his Oregon medical license while under investigation.

SMITH, Randall Jay, DO; DO15715; PORTLAND, OR

Licensee entered into a Interim Stipulated Order with the Board on March 4, 2004. In this Order licensee agreed to withdraw from practice pending the conclusion of the Board's investigation regarding his competency to practice medicine.

Licensee entered into a Voluntary Limitation with the Board on January 15, 2004. Licensee entered into a Stipulated Order with the Board on March 4, 2004. In this Order he agreed to surrender his Oregon acupuncture license on March 31, 2004 at 5:00 p.m. Licensee also agreed to never reapply for Oregon acupuncture licensure.

VAN PETT, Kasia, MD; MD20623; EUGENE, OR

Licensee entered into a Corrective Action Order with the Board on March 4, 2004. In this Order Licensee agreed to obtain CME related to endoscopic carpal tunnel surgery. Licensee must successfully perform 10 endoscopic carpal tunnel surgeries under the supervision of a mentor before she can perform them solo.

Licensee entered into a Corrective Action Order with the Board on October 14, 2004. In this order Licensee agreed to complete CME courses addressing clinical skills, interpersonal skills, and disruptive behavior if he continues to practice solely in the military. Licensee entered into a Stipulated Order with the Board on May 6, 2004. This Order placed Licensee on 10-years of probation, reprimand, fine, stayed 30-day suspension, quarterly Board reporting, coursework in ethics, no notice Board inspection of billing and medical records regarding use of CPT codes.

WITTKOPP, GEORGE FRED, MD; MD10695; WEST LINN, OR

The Board issued a Final Order on October 25, 2004. Licensee is placed on probation; Licensee is suspended from practice but suspension was stayed conditional upon Licensee's successful compliance with the terms of this Order; Licensee is assessed hearing costs in the amount of \$5, 000; Licensee is required to enroll in and successfully complete of the educational program recommended by the Center for Personalized Education for Physicians (CPEP); boundary course; no-notice Board compliance inspections; quarterly Board reporting.

Via his court appointed conservator, Licensee entered into a Stipulated Order with the Board on January 15, 2004. In this Order, Licensee agreed to surrender his Oregon medical license while under investigation.
