ADAMS, Ralph Edwin, MD; MD05512; Salem, OR

The Board issued an Order of Emergency Suspension on July 19, 2005. The Board took this action based on its immediate concerns regarding the safety and welfare of Licensee's current and future patients. A final action in this matter has not been taken.

ALTER, Dale Newton, MD; MD20858; Madras, OR

Licensee entered into an Interim Stipulated Order with the Board on January 13, 2005. In this Order Licensee agreed to withdraw from practice pending the conclusion of the Board's investigation into his competency to practice medicine. This is not a final action by the Board.

On April 14, 2005, the Board issued an Order Terminating Interim Stipulated Order which returned Licensee back to practice.

Licensee entered into a Stipulated Order with the Board on July 14, 2005. In this Order Licensee agreed to the following conditions: 10-year probation; reprimand; quarterly Board reporting; compliance with his Health Professionals Program contract; may not write prescriptions for family members or social acquaintances and only in a clinical setting; annual neuro-ophthalmologic evaluation of eyes; must have primary care physician.

BERGIN, Patrick John, MD; MD15838; EUGENE, OR

The Board issued a Final Order on February 3, 2005. This Order suspended Licensee's Oregon medical License until he completes a multi-disciplinary evaluation. This Order also imposed a reprimand, \$2000 fine, assessment of contested case hearing costs, and prohibits use of alcohol and controlled substances which is to be verified w/random UA's

BERRY, Douglas Foreman, MD; MD12708; Bend, OR

Licensee entered into a Stipulated Order with the Board on July 14, 2005. In this Order Licensee agreed to permanently retire his Oregon medical license while under investigation. Licensee agreed to never reapply for an Oregon medical license. In addition, Licensee was reprimanded.

BLATCHFORD, DOUGLAS MILLS, MD; MD07450; GRESHAM, OR

Licensee entered into an Interim Stipulated Order with the Board on July 15, 2005. In this Order Licensee agreed to the following practice terms while the Board completes its investigation regarding alleged sexual misconduct: Chaperone required for all female patients over the age of 12; no dating or sexual relationships with any current or former patients; and provide copy of Order to chaperone and all employers.

Licensee entered into an Amended Interim Stipulated Order (ISO) on November 3, 2005. This Order amends the previous ISO, dated July 15, 2005, by specifying that the required chaperone must not be a relative of the patient or the Licensee. Like the previous ISO, this order requires Licensee to use a chaperone when examining or treating any female patient over the age of 12-years-old. In addition Licensee is prohibited from engaging in a dating or sexual relationship with any current or former patient. Licensee must provide a copy of the ISO to any chaperone, clinic where he practices, or hospital where he currently has privileges. This Order will remain in effect until the Board takes a final action in this matter.

Licensee entered into an Interim Stipulated Order with the Board on November 14, 2005. In this Order Licensee agreed to withdraw from the practice of medicine and will not resume practice until he receives written notice from the Board to resume practice. A final action in this matter has not yet been taken.

BOESPFLUG, RANDOLPH ROY, MD; MD15363; MONMOUTH, OR

Licensee entered into a Corrective Action Order with the Board on January 14, 2005. In this Order Licensee agreed to have a practice preceptor who shall submit quarterly progress reports to the Board; CME in charting; utilize problem and medication lists in charts.

BURLESON, David Oliver, MD; MD15077; Portland, OR

Licensee and the Board entered into an Interim Stipulated Order on 4/19/05. In this order Licensee agreed to withdraw from practice pending the conclusion of the Board's current investigation.

On May 5, 2005 the Board issued an Order Rescinding Order of Emergency Suspension which rescinded Licensee's April 18, 2005 Order of Emergency Suspension.

The Board issued an Order of Emergency Suspension on April 15, 2005. This Order immediately suspends Licensee's license pending further action by the Board. The Board took this action due to immediate concerns regarding Licensee's ability to safely practice.

Licensee entered into a Stipulated Order with the Board on October 6, 2005. In this Order Licensee agreed to surrender his Oregon medical license while under investigation. This Order also places conditions on Licensee should he decide to reapply for licensure after the passage of two years.

CAMPBELL, Robert Perry, MD; MD10884; PORTLAND, OR

Licensee entered into an Interim Stipulated Order with the Board on June 23, 2005. In this Order, Licensee agreed to practice conditions while the Board completes its investigation. Practice conditions include participation in the Health Professionals Program; weekly group and individual therapy; follow all recommendations of therapists/providers; therapists/providers shall submit quarterly reports to the Board; shall use medically trained chaperone when treating female patients; maintain appropriate professional/personal boundaries; no notice practice inspections to ensure compliance.

DAY, FLOYD DOUGLAS, MD; MD05881; PORTLAND, OR

Licensee entered into a Stipulated Order with the Board on January 13, 2005. In this Order Licensee agreed to a reprimand; \$2,500 fine; successfully complete either PEER or CPEP; and successfully complete the Board's Appropriate Prescribing Workshop.

DENISON, Darryl Bruce, PA; PA01059; Portland, OR

Licensee entered into a Stipulated Order with the Board on December 1, 2005. The terms of this order are as follows: provide copy of this order to all supervising physicians; supervising physician to provide quarterly progress reports to the Board; psychological evaluation and care w/quarterly reports to the Board.

DIERDORFF, John Terence, DO; DO06866; Hillsboro, OR

Licensee entered into a Stipulated Order with the Board on January 13, 2005. In this Order Licensee agreed to a 10-year probation; reprimand; fine; 45-day suspension to begin on 1/14/05; chaperone for female patients over the age of 12; quarterly Board reporting; CME related to physician/patient boundaries; psychotherapy with quarterly reports.

DUBIN, David Alexander, MD; MD25083; PORTLAND, OR

Licensee entered into a Stipulated Order with the Board on April 15, 2005. By signing this Order, Licensee surrendered his Oregon medical license. This Order also terminated his April 14, 2004 Voluntary Limitation.

EDWARDS, ROBERT NORFLEET, MD; MD14941; KLAMATH FALLS, OR

Licensee entered into an Interim Stipulated Order with the Board on July 25, 2005 in which he agreed to have a Board approved physician over-read all of his nuclear medicine scans for which Licensee provides an interpretation. This over-read must be done within 72-hours. This order went into effect on July 15, 2005, the date Licensee signed the Order. This is an interim order which will remain in effect until the Board concludes its investigation into Licensee's interpretation of nuclear medicine scans.

EKLUND, Gilbert Willard, MD; MD07826; Beaverton, OR

Licensee entered into a Corrective Action Order with the Board on February 25, 2005. In this Order, licensee agreed to have a Board approved practice mentor who shall submit quarterly progress reports to the Board. In addition, licensee will submit a written educational plan to the Board before performing any invasive breast procedures.

ELLISON, MONTY ROSS, MD; MD07648; ALBANY, OR

Licensee and the Board entered into a Stipulated Order on March 3, 2005. In this Order the Board allowed Licensee to retire his Oregon medical license while under investigation. In addition, if Licensee re-applies for licensure after a period of two years, Licensee must comply with various conditions regarding his ability to safely and competently to practice medicine.

ERDE, Karen Madeline, MD; MD10738; Portland, OR

Licensee entered into a Corrective Action Order with the Board on 4/15/05. In this Order Licensee agreed to enroll in a Board approved mini-residency or other training; Licensee must practice in a hospital or group setting under a Board approved mentor. After Licensee completes the above terms, but no sooner than 18 months from the approval date of this Order, Licensee may ask the Board to terminate this Order.

ERICKSON, CARL MICHAEL, DO; DO12690; PORTLAND, OR

Licensee entered into a Corrective Action Order with the Board on July 14, 2005. In this Order Licensee agreed to have a Board approved practice mentor review at least five chronic pain patient charts per month with quarterly reports to the Board. Licensee will complete courses in appropriate prescribing and pain management.

FAULK, CHARLES EDWARD, MD; MD10505; SALEM, OR

Licensee entered into a Stipulated Order with the Board on July 14, 2005. In this Order Licensee agreed to the following terms: probation; practice conditions upon Licensee's return to active practice in Oregon; psychiatric care; no self-prescribing.

FREEMAN, DALE OWENS, AC; AC00213; SHERIDAN, OR

Licensee entered into a Stipulated Order with the Board on March 3, 2005. In this Order Licensee was reprimanded, required to take CME in professional boundaries, charting, and patient communication; Licensee must provide informed consent before providing treatment to and near sensitive areas of the body; Licensee must offer a chaperone for female patients over 12 years old. When treating breast or genial area, Licensee must have a chaperone during that portion of exam.

GROBOVSKY, LAURA VANINI, MD; MD22573; MEDFORD, OR

On July 14, 2005 the Board issued a Final Order regarding Dr. Grobovsky. This Order imposed the following terms: Reprimand; \$3,000 fine; costs of disciplinary proceedings; minimum 30-day suspension pending Licensee's completion of a multi-disciplinary evaluation and other terms; once suspension is lifted Licensee will be placed on probation and be required to continue compliance with all treatment and monitoring recommendations resulting from the evaluation.

HARDY, JOHN HENRY, MD; MD18862; VANDENBERG AFB, CA

Licensee entered into an Interim Stipulated Order with the Board on March 3, 2005. In this Order Licensee agreed that his Oregon medical license is limited to practicing as a physician while on active duty carrying out military related missions as a commissioned officer in the United States Air Force and agreed to provide the board with a copy of any action taken by the military regarding its current investigation of Licensee.

HOLEMAN, THOMAS ALFRED, MD; MD07269; MILWAUKIE, OR

The Board issued a Final Order on January 13, 2005. This Order revoked Licensee's Oregon medical license and imposed a \$5,000.00 fine and contested case hearing costs.

IHARA, Dennis Minoru, MD; MD13753; Winchester, OR

Licensee entered into a Stipulated Order with the Board on October 6, 2005. In this Order licensee agreed to retire from the active practice of medicine and practice only under an emeritus status (volunteer). Licensee's practice as an emeritus is limited to volunteer non-obstetrical, non-surgical gynecological practice. The only exceptions are the conditions placed on Licensee's ability to perform the loop electrosurgical excision procedure (LEEP).

JOHNSON, MARTIN CLIFTON, MD; MD07192; WILSONVILLE, OR

Licensee entered into a Corrective Action Order on July 14, 2005. In this Order Licensee agreed not to self-prescribe medications for himself or his family.

JOHNSON, RAYMOND MARTIN, MD; MD05829; CORPUS CHRISTI, TX

Licensee entered into a Stipulated Order with the Board on January 13, 2005. This Order terminates Licensee's 1980 Voluntary Limitation under the condition that Licensee surrendered his Oregon medical license.

JOHNSON, SUSAN HARRINGTON, MD; MD17446; PORTLAND, OR

Licensee entered into a Corrective Action Order with the Board on February 3, 2005. By signing this Order, Licensee agreed to enroll in and complete the Physicians Evaluation Education Renewal (PEER) program.

JURLING, Owen David, MD; MD17446; Jacksonville, OR

Applicant entered into a Corrective Action Order with the Board on December 7, 2005. In this Order, Applicant was granted an Oregon acupuncture license unter the following condition: Applicant shall obtain a practice mentor under the conditions specified in the Board's Acupuncture Mentorship Outline.

KELLOGG, Jordi Xirinachs, MD; MD22765; PORTLAND, OR

Licensee entered into a Stipulated Order with the Board on January 13, 2005. This Order placed Licensee on 10 years of probation under the following terms: reprimand; fine; quarterly Board reporting; communications course; practice proctor with monthly reports to Board; maintain current records/chart notes.

LENTINI, JEROME NICHOLAS, MD; MD19171; SALEM, OR

Licensee entered into an Interim Stipulated Order with the Board on January 14, 2005. In this Order, Licensee agreed to temporarily withdraw from practice pending the conclusion of the Board's current investigation. Licensee's withdrawal from practice became effective on January 7, 2005, the date he signed the Order. This is not a final action by the Board.

LITWER, LAWRENCE RONALD, MD; MD16741; GRESHAM, OR

Licensee entered into a Stipulated Order with the Board on October 6, 2005. In this Order Licensee agreed to complete the Physicians Evaluation Education Renewal (PEER) program within 24 months.

LOPRESTI, Anthony Joseph, MD; MD16741; Pacific Grove, CA

Licensee entered into a Corrective Action Order with the Board on July 14, 2005. In this Order Licensee was granted an Oregon medical license under the condition that he participate in PEER and obtain preapproval from the Board of all Oregon practice settings.

MANTLE, William Nelson, MD; MD25820; Scottsdale, AZ

Licensee entered into a Stipulated Order with the Board on March 18, 2005. In this Order, Licensee was granted an Oregon license under the condition that he notify the Board if and when he decided to practice any form of clinical medicine. Licensee agreed to execute a continuing education training program in clinical medicine prior to resuming clinical practice.

MANUELE, Kenneth Wayne, DO; DO19106; Brookings, OR

Licensee entered into a Corrective Action Order with the Board on 4/15/05. In this Order, Licensee agreed to continue treatment with a Board approved psychiatrist who shall submit quarterly progress reports to the Board.

MCCANN, DAVID MICHAEL, MD; MD17888; ORANGEVALE, CA

The Board issued a Default Final Order on October 6, 2005. This order revoked the Oregon medical license of David M. McCann, MD.

MCCASKILL, MICHAEL FREDERICK, MD; MD10666; MEDFORD, OR

Licensee entered into a Corrective Action Order with the Board on 4/15/05. In this Order Licensee agreed to the comply with the following terms: Licensee may not treat Patient A; Licensee may not allow subordinate or employee to treat him unless they are a licensed physician; complete Appropriate Prescribing Workshop; no self prescribing for self or family; must have primary care physician; must keep appropriate patient records for all patients treated or prescribed medications.

MCDUFFIE, Richard Warner, MD; MD09112; Eugene, OR

Licensee entered into an Interim Stipulated Order on May 5, 2005. In this Order Licensee agreed to withdraw from practice pending the conclusion of the Board's investigation. Licensee also agreed to provide releases of information to the Board from various entities.

MEHARRY, LEROY IRWIN, MD; MD11421; Umatilla, OR

Licensee entered into a Stipulated Order with the Board on April 15, 2005. This order contains the following terms: reprimand; may not self prescribe or treat family members; may not work in any health care facility where a family member is employed; may not store narcotic medications or any Schedule II or III controlled substances at any health care facility where he works or his residence.

MISKO, John Charles, MD; MD05892; Portland, OR

Licensee entered into an Interim Stipulated Order with the Board on February 3, 2005. In this Order, Licensee withdraws from the practice of medicine until completion of the Board's investigation.

Licensee entered into a Stipulated Order with the Board on May 5, 2005. In this Order Licensee agreed to retire his Oregon medical license while under investigation. Licensee also agreed to never reapply for an Oregon medical license.

MITCHELL, FREDERICK LEE, MD; MD21015; Newberg, OR

Licensee entered into a Stipulated Order with the Board on July 14, 2005. In this Order Licensee agreed to the following terms: 5-year probation; reprimand; may not prescribe more than four grams of acetaminophen per day to any patient; enroll in and complete PEER, coursework on medical documentation and appropriate prescribing; and quarterly Board reporting.

Licensee entered into an Interim Stipulated Order with the Board on March 3, 2005. In this Order Licensee agreed to the following terms while the Board conducts its investigation: Licensee must provide a material risk notice for patients being treated with narcotics for 3 or more months; Licensee will comply with the Intractable Pain Law; and Licensee will not prescribe more than 4 grams of acetaminophen per day to any patient. Once the Board concludes it's investigation, a final action in this matter will be taken.

MUMFORD, DWIGHT CURTIS, MD; MD08485; BEAVERTON, OR

The Board issued an Order of Suspension of License on October 6, 2005. This action was taken pursuant to ORS 677.225, which requires the Board to suspend a license if the Licensee is adjudged to be mentally ill or is admitted on a voluntary basis to a treatment facility for mental illness that affects the ability of the licensee to safely practice medicine, and if the licensee's residence in the facility exceeds 25 consecutive days.

Licensee entered into an Interim Stipulated Order with the Board on April 26, 2005. The Board approved this Order on May 5, 2005. In this order Licensee agreed to withdraw from practice pending the conclusion of the Board's investigation. Licensee must also complete residential drug and alcohol treatment before he can return to any form of practice. In addition, Licensee shall be subject to random UA's, continue with psychiatric care, and shall abstain from alcohol. This Order shall remain in effect until the conclusion of the Board's investigation into his competency to practice medicine.

NEITLING, Stanley Joseph, MD; MD13059; Tillamook, OR

Licensee entered into a Stipulated Order with the Board on March 3, 2005. In this Order Licensee was placed on 5 years of probation under the following terms: Reprimand; enroll in the Oregon Health Professionals Program; quarterly Board reporting; and provide copies of this Order to hospital or facility where Licensee has privileges.

NIELSEN, CATHERINE HARRIS, MD; MD19382; MCMINNVILLE, OR

Licensee entered into a Stipulated Order with the Board on August 4, 2005. In this order Licensee agreed to comply with the following practice conditions: 5-year probation; education required before Licensee can perform surgical or operative gynecology; once education obtained, must have proctor and assistant for a minimum of 10 gynecological surgical cases; Board review of surgical cases; practice mentor.

PARENT, JEFFREY MICHAEL, DO; DO15942; MILWAUKIE, OR

Licensee entered into a Stipulated Order with the Board on February 3, 2005. In this order, Licensee is placed on 10 years probation with the following terms: reprimand, no solo practice or PA supervision, 20 hours maximum work week, treatment for chronic pain from pre-approved pain specialist, pre-approved CME in family practice, CME prior to treating patients for ADD, no prescriptions written by staff, no self prescribing, annual physical and neuro-psychological examination, quarterly reports from his primary physician, and quarterly Board interviews.

RAGGE, Bonnie Lynn, DO; DO15942; Grants Pass, OR

The Board issued a Final Order on October 6, 2005. This order denied Dr. Ragge's application for Oregon medical licensure. Licensee was also assessed the costs associated with her contested case hearing.

RAY, NANCY THORPE, DP; DP00310; ASTORIA, OR

Licensee entered into a Corrective Action Order with the Board on July 15, 2005. In this Order, Licensee agreed to enter into treatment with a mental health professional that will provide quarterly progress reports to the Board.

REILLY, Dennis Eugene, DO; DO13019; Newberg, OR

Licensee entered into an Interim Stipulated Order with the Board on November 3, 2005. In this Order Licensee agreed not to treat female patients. Licensee agreed not to contact any current or former female patient outside the office setting. Licensee is required to provide a copy of the Order to any clinic or office where he practices.

REXIN, DOUGLAS ALLEN, MD; MD20317; WILLAMINA, OR

On June 23, 2005, the Board issued an Order of Suspension of License in response to notification by the State of Oregon Division of Child Support that Licensee owed child support and was in arrears. Per ORS 25.750 thru 785, the Board is required to take this action. THIS ORDER WAS TERMINATED ON 8/4/05 BECAUSE BOARD WAS NOTIFIED THAT LICENSEE WAS IN COMPLIANCE WITH CHILD SUPPORT.

RIPPLINGER, Joseph John, AC; AC00626; GRESHAM, OR

Licensee entered into a Stipulated Order with the Board on October 7, 2005. In this order Licensee agreed to the following terms: 10-year probation; reprimand; complete coursework on sexual boundaries and professional ethics; may not treat female patients 16 or older; if treating females under 16 must have parent or guardian present; pre-approved practice setting; compliance with professional standards; charts subject to no-notice compliance checks.

ROBINSON, TAYLOR, MD; MD15910; LAKE OSWEGO, OR

The Board issued a Final Order by Default on January 13, 2005. This Order denied Licensee's licensure application.

SMITH, Randall Jay, DO; DO15715; PORTLAND, OR

The Board issued a Final Order against Licensee on April 15, 2005. In this Order, the Board revoked Licensee's Oregon medical license and imposed a \$5,000 fine.

STELSON, Fred Woolley, MD; MD23188; ROSEBURG, OR

The Board issued a Final Order in the matter of Fred Woolley Stelson, MD on July 14, 2005. The Board imposed the following terms in this Order: Reprimand; fine; costs; minimum 6 month suspension; practice conditions imposed if and when he resumes practice in Oregon. These terms include: 10 year probation; quarterly Board reporting; practice limited to psychiatry; complete coursework in appropriate prescribing and sexual boundaries; practice mentor who shall submit quarterly reports to Board; no self treatment or treatment of office associates or employees.

STEPHENS, RYAN SCOTT, DP; DP00306; ONTARIO, OR

The Board issued a Final Order by Default on October 7, 2005. This Order reprimanded Licensee and revoked his Oregon podiatric license.

STEVENSON, RONALD CARLO, MD; MD22232; TIGARD, OR

Licensee entered into a Stipulated Order with the Board on July 14, 2005. In this Order Licensee agreed to surrender his Oregon medical license while under investigation. Licensee may not reapply for licensure for a minimum of two years and must obtain an evaluation before his application can be considered.

TEPLICK, STANLEY BRUCE, MD; MD19317; Beaverton, OR

Licensee entered into a Stipulated Order with the Board on March 3, 2005. In this Order Licensee was placed on probation for 5-years subject to the following terms: reprimand; \$5,000 fine; 30-day suspension to begin within 60-days of the effective date of this Order; Quarterly Board reporting; CME in appropriate prescribing and professional boundaries.

VANSICKLE, DAVID GORDON, MD; MD07617; TUALATIN, OR

Licensee entered into a Stipulated Order with the Board on April 15, 2005. In this Order Licensee retired his Oregon medical license while under investigation. Should Licensee decide to reapply for Oregon licensure at a future date, the Board will reopen investigation.

On February 3, 2005, Licensee entered into an Interim Stipulated Order with the Board in which he agreed to withdraw from medical practice until the conclusion of the Board's investigation. This is not a final action by the Board.

WADE, GARY LYNN, MD; MD16942; YREKA, CA

Licensee entered into a Corrective Action Order with the Board on July 14, 2005. In this Order Licensee acknowledged the requirement and importance of appearing before the Board's Investigative Committee after receiving an invitation to appear; if and when Licensee ever reapplies for an active Oregon license he will have to appear for an interview before the Board's Investigative Committee and he may be required to obtain an evaluation.

WALKEY, MARILYN MILLS, MD; MD18470; Portland, OR

Licensee entered into a Corrective Action Order with the Board on November 3, 2005. In this Order Licensee agreed to the following terms: Board approved practice setting (excluding acupuncture); Board approval to practice outside of radiology specialty (excluding acupuncture); continue current treatment with psychiatrist with reports to the Board; practice mentor is Licensee resumes practice of radiology with quarterly reports to the Board; no self-prescribing; if Licensee does not practice medicine for two years after the date of this Order and she submits a request to reactivate her Oregon license she must appear before the Board's Investigative Committee to address competency.

WHANG, Edward Keesan, MD; MD10381; PORTLAND, OR

The Board issued an Order of Emergency Suspension on September 1, 2005. This action was taken due to Licensee's non-compliance with a Board order, Board concerns regarding possible neurocognitive impairment, and Board concerns regarding inappropriate physician patient boundaries.

Licensee entered into an Interim Stipulated Order with the Board on May 5, 2005. In this Order Licensee agreed to stop taking new patients; close his medical office and cease practice by 12/31/05; and use a chaperone when treating any female patients. This order remains in effect until the Board completes its investigation.

WINANS, WILLIAM EDWARD, DO; DO07880; TUALATIN, OR

Licensee entered into a Stipulated Order with the Board on October 6, 2005. In this Order, Licensee agreed to permanently retire his Oregon license while under investigation. This order also prohibits licensee from practicing in a volunteer capacity.

WITTKOPP, GEORGE FRED, MD; MD10695; WEST LINN, OR

Licensee entered into an Interim Stipulated Order with the Board on February 3, 2005 in which he agreed to withdraw from medical practice until he satisfactorily completes the terms of his Final Order dated October 25, 2004.

The Board issued a Final Order on July 14, 2005 regarding Dr. Wittkopp. This Order revoked Licensee's Oregon medical License.

ZAHORIAN, George Thomas, MD; APPLICANT; Clifton, NJ

Applicant entered into a Stipulated Order with the Board on February 3, 2005. In this Order, Applicant would be granted an Oregon license and placed on probation with the following conditions: Applicant agreed to have a practice mentor who shall review 10% of his charts on a quarterly basis, pass SPEX, no dispensing privileges, no prescribing of anabolic steroids, Board inspection of his practice, and quarterly probation interviews.
