## ATTENTION TAX PREPARERS! IMPORTANT THINGS FOR YOU TO KNOW!

#### A) TO RECEIVE YOUR PREPARER LICENSE:

- 1. Complete the form on the other side of this page. If your plans for employment are unknown when you apply for licensing, fill out only Sections 1, 2, 5, 6 and 7 of the application.
- 2. Return this completed form, the 80 Hour Basic Course certificate and applicable fee (see Section #6 on other side of this page) to the Board of Tax Practitioners within 60 days of the date of exam. If you do not send the required materials by this deadline, you must retake the exam to become licensed.
- 3. Licenses <u>will not</u> be processed until all required information and fees are received and processed by the Board office.
- 4. Licenses must be conspicuously displayed in the holder's place of tax employment.
- 5. No continuing education credit is required for the <u>first renewal</u> of a tax preparer's license. A minimum of <u>30 hours</u> continuing education must be completed during each license period thereafter.

### B) OWNER/OPERATOR OF A BUSINESS:

- 1. If you will be an owner/operator of a business that offers tax preparation services, contact the Board of Tax Practitioners prior to advertising or offering services.
- 2. Tax preparer licenses and tax business registrations expire September 30 following initial issuance. The Board office will mail out Preparer Renewal Notices to the address that the Board office has on file at least 30 days prior to expiration date.
