Under ORS 469.441, the Energy Facility Siting Council (Council) must establish a schedule of fees to be paid at the time an applicant submits a notice of intent, a request for an exemption, a request for a pipeline described in ORS 469.405(3) or a request for an expedited review. Oregon Revised Statutes (ORS) 469.421 requires any person submitting the following documents to pay all expenses incurred by the Council, the Office of Energy (Office) and the Department of Administrative Services related to the review and decision of the Council:

Notice of Intent

- Request for Exemption
- Request for Expedited Review
- Request for the Office of Energy to Approve a Pipeline under ORS 469.405(3)
 - Application for a Site Certificate
 - Request to Amend a Site Certificate

In the case of an Application for a Site Certificate, ORS 469.421(3) requires the Office to estimate the costs expected to be incurred in processing the application. The applicant will make periodic payments, starting with 25 percent of the total estimated fee, which is due at the time the applicant submits the application. If total costs exceed the estimate, the applicant shall pay any excess costs itemized in a statement prepared by Council staff. If costs are less than the fee paid, Council staff shall refund the excess to the applicant.

In the case of a Request to Amend a Site Certificate, Council staff periodically bills the applicant for actual costs incurred. The applicant shall pay the amount due upon receipt of each billing statement.

In the case of a notice of intent, a request for exemption, a request for a pipeline under ORS 469.405(3) or a request for expedited review, the applicant shall pay the amount shown on the following fee schedule at the time that the applicant submits the notice or request. The fee schedule is established to recover all expenses incurred by

the Council and the Office related to the review and decision of the Council. If actual 1 2 costs exceed the fee, the applicant must pay any excess costs itemized in a statement 3 prepared by Council staff. If costs are less than the fee paid, Council staff shall refund 4 the excess to the applicant. 5 The Council finds that this matter is of substantial and immediate concern and 6 that the Council should not defer action until the next regular Council meeting. 7 With this order, the Council sets the following general fees. All fees noted 8 below are due at the time that the applicant submits the notice or request.
