Schedule of Forest Service Land Management Plan Revisions & New Plans

September 10, 2008

The following four tables display the updated Service-wide Land Management Plan (LMP) Revision Schedule for each unit of NFS by fiscal year as well as the schedule for the development of new plans for recently established units of NFS. Table 1 lists plan revisions completed to date. Table 2 lists plan revisions already underway. Table 3 lists anticipated start dates for upcoming plan revisions. Table 4 displays the schedule for development of new plans for two recently established units of NFS, the Midewin National Tallgrass Prairie and the Land-Between-the-Lakes National Recreation Area.

Posting of this schedule does not constitute an initiation of a plan development or revision process for any NFS unit. A Notice of Intent to develop or revise a plan, which is published in the Federal Register as well as in newspapers of general circulation within the area covered by the plan, initiates the revision process for each plan. Additionally, this posting of the schedule on the Forest Service Ecosystem Management Coordination staff website does not, in itself, constitute an action subject to the National Environmental Policy Act (NEPA) procedures of 40 CFR parts 1500 – 1508 or Forest Service NEPA procedures, 36 CFR 220, or Forest Service Handbook 1909.15. The Service-wide LMP Revision Schedule will continue to be adjusted as necessary and, at regular intervals, posted on the Forest Service Ecosystem Management Coordination staff website at www.fs.fed.us/emc/nfma.
