Vision Statement

The staff of Antietam National Battlefields vision for the National Park Centennial consists of five seperate but inter-connected areas of stewardship. We will strive to maintain the highest level and standards of Resource Stewardship and Protection for the Cultural and Natural resources that make up the National Battlefield. In conjunction with these actions we will re-energize our process to restore the historic landscape to its appearence on September 16, 1862 as described in our enabling legislation and General Management Plan. Our goal is to preserve, protect and restore the Battlefield to serve as an open air classroom. We will provide a safe environment where visitors have the opportuntity to learn, reflect and appreciate the sacrifice made here.We will strive to make available to Battlefield Visitors opportunities to fully experience the battlefield through the use of a effective and low impact trail system that makes them one with the resource and its history. We will strive to enhance visitor understanding, appreciation and experience by providing multiple types and levels of educational and interpretive programming using the newest technologies available but never losing the human contact between Park Service staff and our visitors. One of the opportunties we would pursue is the Crossroads of War Web Site, this joint project will allow the public to view multiple stories and place the Civil War History of the Mid Atlantic into context. We will continue to move our educational programs to the highest standards, to search for audiences and to provide opportunties for every generation to connect with the resource. We will pursue and develop cooperative relationships with Federal, State and private sector groups to enhance the protection, interpretation and opportunties found in this area and geographical region. We will strive to create and maintain partnerships with Tourisim Agencies at all levels who support Heritage Tourisim and its economic advantages. We will provide a safe and secure environment for employees who work at this special place. We will strive to become better public servants and to insure that we use any funds provided, whether public or private, in an cost efficient and effective manner to further the stewardship of Antietam.
