BRIEF DESCRIPTION OF ACCIDENT

An employee fell from an elevated scaffold work platform of 21 feet above the ground level attached to a Lull Minneapolis-Moline tractor with a West Super-Skytrak variable reach forklift. The employees were removing windows from a wall when the forklift tipped over.

ACCIDENT PREVENTION RECOMMENDATIONS

1. All machinery and equipment shall be inspected prior to use at the beginning of a workshift. If the machinery or equipment is found to be unsafe, it should be tagged or locked out to render it inoperable.

- 3. Instruct employees on the recognition and avoidance of unsafe conditions, and on the regulations applicable to controlling or eliminating hazards in the work environment.
- 4. Instruct and train employees operating a fork lift truck with a scaffold work platform attached to the fork, to not move the equipment horizontally when employees are raised on the work platform.

Note: This case described was selected as being representative of improper work practices which likely contributed to a fatality from a fall. The accident prevention recommendations do not necessarily reflect the outcome of the legal aspects of the incident case.
