BRIEF DESCRIPTION OF ACCIDENT

The employee was working alone on the flat rooftop of a residence, applying caulking in preparation to paint. The employee fell off the back edge of roof approximately 25 feet onto a wooden deck below. The employee had no fall protection training (in his Spanish language) and was not provided any fall protection.

ACCIDENT PREVENTION RECOMMENDATIONS

- 1. Provide fall protection
- 2. Train employees in fall protection.

Note: This case described was selected as being representative of improper work practices which likely contributed to a fatality from a fall and/or electrocution. The accident prevention recommendations do not necessarily reflect the outcome of the legal aspects of the incident case.
