Entry level and experienced attorneys.

Both entry level and experienced attorneys are hired throughout the year as vacancies arise. Entry level attorneys are selected based on academic performance in law school, writing ability, achievements during law school (moot court, law review), work experience during law school and any other experience related to the work of the Department of Health and Human Services. Entry level attorneys are generally hired at the GS-11 level. Experienced attorneys are selected using the same criteria; however, their entry level grade is dependent upon their work experience since graduation from law school.

Summer Intern Program.

Each year law students are brought in to serve as interns, paid or for course credit, during the school year and the summer. Each intern usually works for a particular division or regional office. A summer intern is expected to work for ten to twelve weeks, although some interns are permitted to split the summer with other employers. Historically, offers of employment have been made to those interns in the program who have performed well.
