Chapter III, Page III-67, Forest-wide Management Direction for Scenic Environment: Add this new standard to the management direction table for scenic environment after Standard SCST02.

Standards	SCST03	In utility corridors (designated in Errata #2, Appendix I, page 7), seek to meet a VQO of Maximum Modification (MM) in the right-of-way clearing width.

Chapter III, Page III-100, Hells Canyon Management Area 1 Direction: Add the following row to the management direction table for Management Area 1, Hells Canyon, under “Rangeland Resources” after Objective 0136.

MPC/Resource Area	Direction	Number	Management Direction Description
Rangeland Resources	Guideline	0142	Within bighorn sheep habitat emphasis areas, close sheep allotments as they become vacant, or convert them to cattle where appropriate, to eliminate the risk of disease transmission from domestic to wild sheep. Do not convert cattle allotments to sheep allotments within occupied bighorn sheep habitat.
