December 7-8, 2008

Benefits from participating in the activity:

This will be an excellent opportunity for companies to participate in the rapidly growing Northern China food and beverage market in one of China's fastest growing major cities and the gate way for all of Northern China. WUSATA's contractor will set up individualized meetings for companies to meet with importers and distributors in Beijing. Interpreters will also be provided.

The Nevada Commission on Economic Development, in cooperation with WUSATA, will be coordinating participation in the following activity:

Interpreters will also be provided. Reimbursement of one-way airfare between Shanghai and Beijing, and 2 nights lodging in Beijing are included with the mission. Space is <u>limited to 10 companies</u> and a maximum of 2 people per company is allowed.

If you are already an exhibitor in the WUSATA section of FHC Shanghai 2008 there is no additional cost for the mission. If you are not an exhibitor in the WUSATA section at FHC-Shanghai there is a cost of \$495.00 per person.
