# **ODA INVESTIGATES FURADAN MISUSE ON ONIONS**

ODA is continuing its regulatory efforts to investigate the illegal use of Furadan on some onion fields in Oregon. These investigations were launched in response to allegations of widespread off-label use of this carbamate insecticide to control thrips. To date, ODA has confirmed numerous growers whose onion fields have tested positive for Furadan residue (active ingredient carbofuran) in foliage and

soil. Investigators continue to gather information, including residue test results, eye-witness accounts and pesticide sales/use records to build cases against potential violators. The United States Environmental Protection Agency (EPA), Region 10, is also evaluating the illegal use of Furadan on onions in Oregon. The use of a pesticide product inconsistent with its label language is considered a violation of state and federal law. Any information you feel might be useful to these investigations may be given anonymously to ODA investigators and is greatly appreciated. Call 503-986-4635.

### **NEW DEALER REQUIREMENTS FOR CARBOFURAN**

In response to unlawful uses of pesticide products containing carbofuran documented during the 2006 crop-growing season, ODA is amending Oregon Administrative Rule 603-057-0140. The amendments will add additional recordkeeping and reporting requirements for pesticide dealers selling or distributing pesticides containing the active ingredient carbofuran. The new requirements are as follows:

- In addition to the standard recordkeeping requirements for the sale and distribution of any restricted use pesticide, the following information must be kept:
- The name and address of the person who received the product when the product was not delivered directly to the purchaser;
- $\bigcirc$  *The crop(s) to which the product will be applied;*
- The acreage of each crop to which the product will be applied;
- The amount of product that will be applied to each acre of each crop;
- The intended date of application to each crop.
- This additional information will be obtained by the dealer from the person receiving the product at the time of distribution or sale.
- All information prepared for every distribution or sale of a pesticide product containing the active ingredient carbofuran shall be submitted by the dealer to the department within five business days of the distribution or sale.

This temporary rule will become effective March 1, 2007. ODA will also propose this rule be made permanent, holding a public hearing and accepting public comment. For more information call 503-986-4635 or visit:

#### **Q&A: PURS**

Development of the Oregon Pesticide Use Reporting System (PURS) is finished and the secure web site is fully operational for those who need to file their 2007 reports. The following are some of the common questions we get about PURS:

#### Do I need to file my 2006 reports?

Pesticide applications made in 2006 do not need to be reported. The PURS web site will give you an error message for reports entered with a date of 2006.

I am trying to file a report but having trouble. I get to the Create Use Report and fill in page 1. When I try to continue, it says the entered ID does not match any reporters I am proxy for. I'm stuck. Can you help?

In this situation, you probably registered as a proxy reporter. Proxy reporters are those who file reports on behalf of other pesticide users, such as "John's Reporting Service." If you are reporting for yourself, your employer or other employees of your business/agency, then you are a self reporter. The solution is to register again as a new reporter with the designation of self reporter.

#### Do I need to report that I have not applied pesticides?

No. If you do not make any pesticide applications in 2007 then you do not need to report into the PURS system.

# I understand that disinfectants do not need to be reported. What about antibiotics?

Antibiotics used in veterinary medicine are not typically EPA registered products and therefore, would not be subject to reporting under PURS. Some antibiotics are registered for bacterial control on crops and would need to be reported.

### We have four separate vegetable farms in the Willamette water basin. Do the farms need to be separated for reporting?

You can register as either one reporter for all four farms or have a separate reporter for each farm. The advantage of having all of the farms together under one reporter ID is that you can aggregate (add up all of the amounts of) pesticides used and possibly have fewer reports. You can aggregate applications within a single calendar month as long as pesticides were used in the same site category, specific site, and location. In the example, four vegetable farms in the Willamette water basin would have the same PURS site category (Agriculture), specific site (Vegetables) and location (Willamette water basin). There is no advantage from the perspective of PURS in keeping pesticide application reports separate for each of the farms, but it may make more sense for your own needs to have each farm location register separately.

#### I filed my report but now I can't do EDS. What do I do?

If you have saved your reports using the Create Use Report

button from the main menu, you do not need to do anything with EDS (electronic data submission). EDS is only for those who have set up special programs on their computers to upload a file with a large number of reports.

#### Where can I get help with PURS?

# CARZOL PLANTBACK RESTRICTIONS

If you used Gowan/Carzol SP (EPA Reg #10163-265 Oregon Section 18#2006OR019) on onions for thrips control (limited to Marion, Clackamas and Malheur counties), this is a reminder of the plantback restrictions associated with such use.

The **required** plantback intervals are:

- No restrictions for alfalfa
- 30 days for leafy vegetables
- 120 days for root crops
- 12 months for ALL OTHER CROPS

EPA approval of Oregon emergency exemptions rely on compliance. The Section 18 process is critical for many crops. It is not worth jeopardizing Oregon agriculture commodities by not following label restrictions. Compliance with Section 18 labels is mandatory. ODA Pesticides Division enforcement may obtain samples for pesticide analysis at any time to verify plantback restrictions.

#### **DEALER RECORDS**

Upon inspection of records from several dealers, ODA pesticide investigators observed that it is common for dealers to list the farm name for restricted-use pesticide sales instead of the applicator name and license number. Dealers must record the applicator's name and license number for each restricted-use pesticide purchase, while farm name is optional. The following information is also required: purchaser's address, date of sale, pesticide trade name and quantity of product sold.

#### Purchasers need to assist dealers

Help your dealer stay in compliance by doing the following things:

- Provide your license for each RUP purchase. Don't give your dealer a "hard time" about showing your license.
- Have the right categories. Commercial and public pesticide applicators' categories must match the pesticide(s) being purchased.
- If you are a consultant, purchase RUPs only for demonstration or experimental use. The Private Pesticide Applicator License is required for RUPs used on your own farm.
- If you are a trainee, you may not purchase RUPs. Instead, have your supervisor make the purchase.

Remember: Dealers have the right to refuse the sale if they suspect you are not properly licensed to use the product.

# MULTIPLE DEALER LOCATION LICENSING

A Pesticide Dealer License is required for **any** physical location where Restricted Use Pesticides (RUPs) are offered for sale or distributed to end-users. Retailers with multiple outlets must have a license for each outet. If RUPs are distributed (shipped to the customer) from a location completely different from where customers go to purchase or order the pesticides, the distirbution center must also be licensed. Even out-of-state facilities that ship or transport RUPs to end-users with an Oregon address must have the Oregon Pesticide Dealer License.

#### **Q&A: NON-PROFIT OPERATORS**

I run a non-profit organization. We want to spray weeds for other landowners as part of a riparian restoration project. Do we need to be licensed?

Yes. Even if you do not charge individual landowners, the non-profit is still considered a pesticide operator. Under ORS 634, a pesticide operator is defined as "a person who owns or operates a business engaged in the application of

pesticides upon the land or property of another." Furthermore, businesses are defined under ORS 648 to include "nonprofit, social, fraternal and charitable entities and unincorporated associations," in addition to entities conducting activities for commercial gain.

Also keep in mind that all persons making pesticide

applications as employees of the non-profit organization must also be licensed as either Commercial Pesticide Applicators or as a commercial trainee working under the supervision of a Commercial Pesticide Applicator. For most riparian areas, where the land is not under agricultural or forestry production, the Ornamental and Turf Herbicide category is required, but certain circumstances might dictate the applicators have other categories as well.

#### PROPOSED RODENTICIDE CHANGES

In the January 17, 2007, Federal Register, EPA announced that its proposed risk mitigation measures for nine rodenticides were available for review and comment with comments due March 19, 2007.

The risk mitigation measures being proposed cover rodenticide bait products containing the following nine active ingredients: brodifacoum, bromadiolone, difethialone, chlorophacinone, diphacinone, warfarin, zinc

EPA is proposing three risk mitigation measures:

phosphide, bromethalin, and cholecalciferol.

 Classifying all bait products containing the active ingredients brodifacoum, bromadiolone, and difethialone as restricted use pesticides.

- Requiring that all outdoor, above-ground placements of bait products containing the active ingredients brodifacoum, bromadiolone, and difethialone be contained in tamper-resistant bait stations.
- Requiring residential rodenticide bait products available for sale to consumers be sold in a tamper-resistant bait station, with solid bait blocks as the only permissible bait.

#### \*Pesticide Violations:

- ORS 634.372(2) As a pesticide applicator or operator, intentionally or willfully apply or use a worthless pesticide or any pesticide inconsistent with its labeling, or as a pesticide consultant or dealer, recommend or distribute such pesticides.
- ORS 634.372(4) Perform pesticide application activities in a faulty, careless or negligent manner.
- ORS 634.372(8) As a pesticide applicator, work or engage in the application
  of any classes of pesticides without first obtaining and maintaining a pesticide
  applicator's license, or apply pesticides that are not specifically authorized
  by such license.
- ORS 634.372(9) As a pesticide operator, engage in the business of, or represent
  or advertise as being in the business of, applying pesticides upon the land
  or property of another, without first obtaining and maintaining a pesticide
  operator's license. The operator also may not engage in a class of pesticide
  application business that is not specifically authorized by license issued by
  the State Department of Agriculture. The operator also may not employ or
  use any person to apply or spray pesticides who is not a licensed pesticide
  applicator or pesticide trainee.
- ORS 634.372(17) Formulate, deliver, distribute, sell or offer for sale any
  pesticide that has not been registered as required by ORS 634.016.
- ORS 634.372(19) Distribute, sell or offer for sale any pesticide except in the manufacturer's original unbroken package.

Note: All Notices of Violation and Civil Penalties listed in the newsletter are considered "Final order issued."

# **Q&A: PHI INTERVAL**

What does a 7-day pre-harvest interval (PHI) mean? Is it 7 days from time treatment ended or does the treatment day count as Day 1 and from then out to Day 7?

The Agency considers the day of treatment to be Day 0. The 7-day pre-harvest interval (PHI) would start with Day 1 which is the day after the initial treatment with subsequent days to follow in order. Private Pesticide Applicators are not required to record the exact ending time of an application, but if they were to appropriately document treatment ending at, for example 11:00 a.m. on Day 0, then Day 1 would end

at 11:00 a.m. the next day and so forth. For more guidance, consult this EPA document:

# PURSUIT PLUS EC SUPPLEMENTAL LABEL CANCELED

#### **NEW PRODUCT SEARCH ON WEB**

ODA has changed the way the search engine for registered pesticides functions on our web site. Instead of returning all products that are in our database, your search will be narrowed to show products that match a particular registration status. The default status is "registered." If you do not find the product you are looking for under "registered," repeat the search with the "renewal pending" status. In the first few months of the year while we are reviewing registrations, it is common that pesticides will have this status. If you find a product with this status, check back later to verify its registration. Products with a "cancelled" status or that do not appear at all are **not** OK to sell or distribute in Oregon. Please call 503-986-4635 if you have questions about the new search engine or a particular product.



Pesticides Superhero Guy says: Material Safety Data Sheets (MSDS) provide additional health and chemical information. You can request one for a pesticide from the manufacturer or dealer.

#### **NEW LABELS ON OLD PRODUCTS**

Over time, it is not uncommon for pesticide product manufacturers to add new sites or change use directions on the products they sell. If you purchased a product several years ago and still have it in your storage area, there is a good chance that there is a newer label available that may meet your needs better than the old label. While tempting, it is not legal for you to use the product in a manner not covered by the original label even if a newer label for the same product may indicate it is OK. However, supplemental labels are sometimes available from the manufacturer to cover these uses for your older product. You must be in possession of both the supplemental label and the original label before using the product in such a manner.

A good example of this is Baythroid XL. This product has been recently relabeled to include treatment of mixed stands of alfalfa and grass. Older product labels have a statement that prohibits such use. EPA approved a supplemental label to cover this use on older product that may be in the hands of end-users. This label is available on the Bayer Cropscience website.
