This Is a Renewal Year, and the Deadline is Nov. 30

2008 is a renewal year, and the renewal deadline is **NOVEMBER 30, 2008**. All real estate licenses, course certifications, prelicense school, instructor, and substitute instructor registrations, and continuing education provider registrations must be renewed by the renewal deadline to be assured that there is no break in the validity of your license, certification, or registration.

ON-LINE RENEWAL will be offered again! For the 2006 renewal period, an impressive 86.49 % of eligible real estate salesperson licensees, and 81.47% of eligible real estate broker licensees chose the on-line route.

For an industry that uses electronic technology in its day-to-day business, the on-line renewal option should be every licensee's first choice. There will be a **discount on renewal fees** for those licensees who choose the on-line renewal route. More information will be posted on the Commission's website, www.hawaii.gov/hirec, click on Real Estate License Renewals.

In late August, Licensing Branch will mail information to all Principal Brokers (PBs) regarding their associated agents and if they have completed their continuing education (CE) requirement. By law, the PB is responsible for all the licenses of the brokerage firm.

It is highly recommended that **the licenses/registrations of the brokerage firm, PB, BICs, and RBOs be simultaneously renewed during early November** and prior to renewals of all associating licensees to ensure sufficient time to correct any problems and to ensure successful renewals of associating licensees.

If an associating licensee's renewal application is submitted prior to the PB's, BIC's, and brokerage firm's renewal applications, the associating licensee's renewal application will be held in suspense until the PB, BIC(s), and brokerage firm have successfully renewed all licenses.

PBs and BICs should complete all CE requirements immediately as successful renewal includes completion of CE requirements **prior** to submission of a renewal application.

To re-register a branch office, a BIC's license must also be successfully renewed in addition to the PB's license and the brokerage firm's license by the November 30, 2008, deadline.

If the PB's, BIC's, and/or the brokerage firm's license are not successfully renewed **prior** to the associating licensees,

all associating licensees will be renewed on **inactive** status.

Whether license renewals are handled by the individual licensee or the brokerage firm, the PB is responsible for the associating licensee's current and active status.

It is recommended that PBs ensure all associating licensees are current and active by requiring all licensees to submit a photocopy of their 2009-2010 pocket license prior to December 31, 2008. **REMEMBER**, by January 1, 2009, licenses which are not current and active are converted to an inactive or forfeited status.

If this conversion takes place, disciplinary action may occur against the licensee operating under an inactive or forfeited license status, and the consumer may recover all commissions and/or compensations paid.

RENEWING ON ACTIVE STATUS: Individual licensees who renew their license on active status need to complete 10 hours of approved CE courses.

Licensees are required to take at least one mandatory core course. For the current 2007-2008 biennium, the mandatory core course is split into two parts, Part A and Part B. Licensees must complete both parts of the core course to receive the full, four-hour credit.

The CE completion certificates do not have to be submitted with the renewal application unless otherwise instructed. All CE courses should be completed in advance of the date of submission of the renewal application or the license may be renewed on an inactive status.

Any individual licensee not completing the CE requirement will be renewed on an inactive status without further notice.

Based on Hawaii Revised Statutes, Section 467-1.6, "Principal brokers. (a) The principal broker shall have direct management and supervision of the brokerage firm and its real estate licensees. (b) The principal broker shall be responsible for: . . . (6) Setting a policy on continuing education requirements for all associated real estate licensees in compliance with the statutory requirement; . . . (7) ensuring that the licenses of all associated real estate licensees and the brokerage firm license are current and active;" This

means that all principal brokers may include in their policies and procedures manual procedures regarding keeping track of CE courses associated agents have taken during the biennium. For instance, a PB may require that copies of CE course completion certificates be submitted to the PB or BIC.

CE RECORDS: Upon completion of a CE core or elective course(s), a licensee will receive a “purple” colored certificate with either “core” or elective” printed on the left and right sides of the certificate. If a certificate was not issued or is misplaced, please contact the CE provider. This procedure may change shortly with the new Continuing Education tracking system the Commission is reviewing. You will be notified of any changes that are implemented.

Core courses – the Commission has its core course available in both a live classroom presentation and an **on-line version**. “Real Estate Law Update and Agency Overview 2007-2008” (Part A), and “Real Estate Law Update and Disclosure Overview” (Part B) were developed for the Commission by Pacific Real Estate Institute in partnership with ProSchools, Inc. *Note: Part B will be available in June, 2008.*

E-File and E-Pay Your General Excise Tax

The State Department of Taxation recently enhanced businesses’ ability to file and pay their General Excise (GE) tax returns (G-45 and G-49) electronically by eliminating the \$2.50 fee.

It is now free and convenient to e-file and e-pay. However, those taxpayers paying by credit card will have the 2.25% processing fee charged by the credit card companies passed on to them.

All businesses are encouraged to complete and file their GE tax returns online, as well as pay online. Go to: www.ehawaii.gov and click on Electronic Tax Filing.

- You’ll receive confirmation your tax return was filed.
- You’ll receive confirmation your payment was authorized.

Businesses wanting additional information or wanting assistance in filing their first G-45 or G-49 online, please call the Department of Taxation’s Customer Call Center at (808) 587-4242 or toll free at 1-800-222-7572.

Reminder: The annual GE tax return (G-49) is **required** to be filed annually, even if the business has zero income.

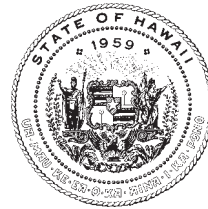

RENEWING ON INACTIVE STATUS: Individual licensees who renew their license on an inactive status do not have to complete the CE requirement but must submit the renewal application and fees by November 30, 2008. An inactive licensee desiring to change to active status shall submit the original CE certificates with a completed Change Form and a reactivation fee.

NEW SALESPERSON in 2008: If you were issued a new salesperson license in calendar year 2008 and renew your license by the renewal application deadline of November 30, 2008, you will be deemed to have completed equivalent to the CE requirement and will not have to complete the CE requirement for this license renewal only.

CANDIDATES FOR LICENSURE: Subject to compliance with the license application deadline, a candidate for licensure may want to consider being licensed as of January 1, 2009, rather than the remaining months of 2008 and be subject to renewal requirements. Please call the Real Estate Branch (808-586-2643) for additional information.

UPDATE ANY ADDRESS CHANGES IMMEDIATELY. During the last renewal in 2006, the Commission received 400 pieces of returned mail due to expired addresses. For the 2008 license renewals, licensees will receive a postcard reminder to renew their license in a timely manner. **Licensees will no longer receive the actual renewal application.**

The Chair's Message

Congratulations to those that have completed Part A of the Real Estate Commission's 2007-2008 Real Estate Law Update and Agency Overview, the first two hours of the four-hour mandatory core course. Part B, Real Estate Law Update and Disclosure Overview will be available in June, 2008, and will complete the mandatory four hours of continuing education requirement. Licensees still must take six hours of elective continuing education courses to meet the required 10 hours of continuing education. Part A brought licensees current with relevant 2006 and 2007 laws changes, and Part B will update licensees with 2008 legislative changes.

The Commission made this change in format based on concerns expressed by licensees, who felt that it was important to learn of changes in the law that impact licensees as soon as the laws pass. The Mandatory Seller Disclosures in Real Estate Transactions law, Hawaii Revised Statutes, Chapter 508D, will be covered in Part B. The course will identify responsibilities of both the seller and the agent. By November 30, 2008, all 10 hours of CE must be completed in order to renew a real estate license on active status for the 2009-2010 licensing biennium. The Education Review Committee is chaired by Maui Commissioner Carol Ball, and she also oversees the Commission's Education Evaluation Task Force (EETF), which is comprised of industry volunteers. The EETF was closely involved in the development of the two-part core course. The EETF is instrumental in making recommendations to the Commission's Education Review Committee on topics related to education, including prelicense curricula, continuing education courses, education equivalency rule changes, and testing and test development issues. In the very near future, the EETF will review the feasibility of requiring post-license education for both salespersons and brokers.

The Laws and Rules Review Committee is chaired by Kauai Commissioner Louis Abrams, and he also oversees the Ad Hoc Committee on Consumer-Broker Relationships. After two years of studying the agency issue as it is manifested in different states and Canada, the conclusions are being finalized, and a decision is nearing regarding any possible changes to the existing Hawaii Administrative Rules that address agency. The concern is that the rules reflect current real estate practices or correct current practices which may not be in the best interests of the consumer. The Condominium Review Committee is chaired by Oahu Commissioner Bill Chee. The Condominium Review Committee has had its hands full since the successful recodification of the condominium law as reflected in the creation

of Hawaii Revised Statutes (HRS), Chapter 514B, which now governs condominium projects and condominium associations in Hawaii. (HRS, Chapter 514A, the original condominium law, is still in effect and must be referred to in conjunction with Chapter 514B.)

During the 2008 legislative session, there were a few house-cleaning bills up for review to fine-tune the new condominium law. The Condominium Review Committee, working together with the Commission's Ad Hoc Committee on Condominium Education and Research, are in the last phase of a project to produce a condominium consumer pamphlet for distribution to condo owners as well as potential new owners. Commissioners Stanley Kuriyama (Oahu broker and Commission Vice Chair), Michele Sunahara Loudermilk (public member and Vice Chair – Laws and Rules Review Committee), Annette Aiona (Big Island broker and Vice Chair – Education Review Committee), Mark Suiso (public member and Vice Chair – Condominium Review Committee) and Commissioner Frances Gendrano Ball (Oahu broker) comprise the full Commission and participate in all standing committee meetings and full Commission meetings. The Commission reviews license applications where prior convictions, judgments, involuntary liens, outstanding tax obligations, disciplinary actions, or pending lawsuits are part of the applicant's history. Settlement Agreements and disciplinary actions also come before the Commission for review and approval. The Commission takes very seriously the allegations and the findings presented, and takes its time in reviewing the sanctions and if they are reflective of the seriousness of the possible violations by the licensee.

There are currently no background checks or fingerprinting checks required from real estate license applicants. The Commission is charged with making the best decision utilizing all the information provided including testimonials from the applicant, and letters of support from associates, friends and family.

As you can see, there is much that goes on within the workings of the Real Estate Commission. The Commission encourages all licensees to familiarize themselves with the different professional organizations that are available. Membership in a professional organization means that standards of practice for specialized areas of the profession are emphasized. For example, the National Association of Realtors (NAR) has its Code of Ethics. The Code of Ethics is a guide to conduct in the course of real estate transactions. Hawaii Administrative Rules, Section 16-99-3(b) mandates that all licensees “. . . protect the public against fraud, misrepresentation, or unethical practices in the real estate field.”

Some of these organizations, locally, are Certified Commercial Institute of Management, (CCIM), Institute of Real Estate Management (IREM), and Hawaii Association of Realtors (HAR). The HAR is the umbrella organization for all Realtor boards statewide. Local boards include the Honolulu

Board of Realtors, Kauai Board of Realtors, Realtors Association of Maui, Inc., Hawaii Island Board of Realtors, and Kona Board of Realtors. Each Board has benefits for their members that may include educational courses, participation in the local political process, industry events, regular newsletters, volunteer opportunities, insurance contacts, discount or dollar savings on retail purchases from car rentals, computer purchases, etc. Locate your Board and be current in your practice and profession.

Administrative Actions

James E. McKellar and Certified Management, Inc.—REC 2007-60-L

In late 2006, Respondents James E. McKellar, a real estate broker, and Certified Management, Inc. renewed their licenses for the period January 1, 2007, through December 31, 2008. RICO alleged that they responded “no” to the question, “In the past 2 years has your license in this state or any other jurisdiction been formally disciplined by way of a fine, suspension, restriction or revocation?” Respondents failed to disclose the fact that on March 24, 2006, the Commission approved settlement agreements which included fines against Respondents. The allegations, if proven, would constitute a violation of the following statutes: HRS §436B-19(5) (procuring a license through misrepresentation); §467-14(20) (failure to maintain a reputation of or record for honesty); §467-14(13) (violating the chapter), §467-20 (filing a document with the Commission that is false or untrue or contains any material misstatement of fact), and HAR §16-99-25 (filing a false statement with the Commission). Respondents waived their right to a hearing and agreed to a disposition of this case in accordance with a Settlement Agreement Prior to Filing of Petition for Disciplinary Action. They stated that the incorrect answers provided on their renewal forms were the result of a clerical mistake, not an intent to withhold information. Respondents entered into this Settlement Agreement as a compromise of the claims and to conserve on the expenses of proceeding with an administrative hearing. Respondents agreed to pay a \$1,000 fine.

The Commission accepted the Settlement Agreement on January 25, 2008.

Makai & Associates, Inc., a Real Estate Broker, Heidi M. Venable, Principal Broker, and Michele M. Foster, a Real Estate Salesperson—REC 2005-239-L

On May 17, 2007, RICO filed with the Office of Administrative Hearings a Petition for Disciplinary Action against Real Estate Licensees; Demand for Disclosure to Respondents. The petition asserted factual allegations concerning Respondents’ conduct as real estate licensees that, if proven by a preponderance of the evidence, might constitute violations of the following laws: HRS §436B-19(2) (Engaging in false or deceptive advertising or making untruthful statements), (17) (Violating this chapter or any rule or order of the licensing authority), §467-1.6(b)(2) (Principal broker responsible for the firm’s records, contracts, and documents), (b)(3) (Principal broker responsible for all real estate contracts and their handling by the associated real estate salesperson), 14(1) (Commission may suspend or revoke any license for misrepresentation concerning any transaction), §467-14(13) (Violating this chapter), (18), HAR §16-99-3(b) (Licensee shall protect the public against fraud, misrepresentation, or unethical practices), (f) (Licensee shall see that financial obligations and commitments are in writing and placed in the hands of all parties

involved), and (u) (Licensee shall not modify the terms of a signed instrument without written consent of all parties). Prior to the hearing date, the parties reached settlement. With regard to the underlying complaint, Respondents asserted they believed they behaved lawfully and appropriately because their actions conformed to the legal advice they received from attorneys who were familiar with the State’s Residential Landlord-Tenant Code, Chapter 521 HRS. Respondents further asserted that in no way did they ever intend to cause frustration or harm and that they at all times attempted to resolve any disagreement in a professional manner. Respondents did not admit violating any law and entered into the Settlement Agreement as a voluntary compromise to conserve on the expense of an administrative hearing. Under terms of the agreement, Respondents agreed to pay \$4,000 restitution to a specified client. Respondents further agreed to pay a \$3,500 fine.

The Commission approved the Settlement Agreement on February 29, 2008.

Michael J.W. Lopez, a Real Estate Salesperson—REC 2007-149-L

RICO alleged that on October 30, 2006, a judgment was entered finding Respondent guilty of driving under the influence. The judgment was based on Respondent’s February 26, 2006 arrest. Respondent disclosed the judgment to the Commission via his November 28, 2006 renewal application. RICO asserted that the allegations in that judgment, if proven at an administrative hearing before the Commission, could constitute violations of at least the following statutes governing the conduct of real estate licensees: HRS §436B-19(12) (failure to adhere to any law in an improper manner for a licensee), (14) (criminal conviction of a penal crime directly related to the duties of the licensed profession), and (17) (violating the chapter).

Respondent agreed to dispose of this case in accordance with this Settlement Agreement prior to Filing of Petition for Disciplinary Action. Respondent agreed to pay a \$2,500 fine.

The Commission approved the Settlement Agreement on February 29, 2008.

John Yeh—REC 2005-172-L

On December 28, 2007, RICO filed a Petition for Disciplinary Action against Respondent, alleging he violated, in part, the following statutes: HRS §467-14(3) (pursuing a continued and flagrant course of misrepresentation), (8) (any other conduct constituting fraudulent or dishonest dealings), (20) (failure to maintain a record or history of competency and fair dealing) and §467-20 (filing a false or untrue document). Respondent admitted to the veracity of the allegations and entered into this Settlement Agreement after Filing of Petition for Disciplinary Action. Respondent agreed to revocation of his real estate salesperson’s license.

Administrative Actions

The Commission accepted the Settlement Agreement on February 29, 2008.

SVC—Hawaii, L.P. and Gretchen I. Watson-Kabei—REC 2004-268-L

RICO and Respondents entered into a Settlement Agreement after Filing of Petition for Disciplinary Action. On June 27, 2007, RICO filed a Petition for Disciplinary Action alleging Respondents violated HAR §§16-99-3(f) and (u). Respondents did not admit to violating any law or rule but

acknowledged that RICO had sufficient cause to file the petition. RICO acknowledged that Respondents have fully resolved all claims as asserted by the reporting party. Respondents entered into the Settlement Agreement as a compromise of the claims and to conserve on the expenses of proceeding with an administrative hearing on this matter. Respondents agreed to pay a \$2,000 fine.

The Commission accepted the Settlement Agreement on March 28, 2008.

Both Part A and Part B will be available in 2008. All other courses are electives and receive 3 hours credit. If you are taking courses to reactivate an inactive license this year, you must first satisfy the prescribed continuing education hours of one prior renewal period.
