ODOT's safety message goes on the road, visits Capitol on Wednesday

The Oregon Department of Transportation has found a new way to get the word out about work zone safety — and it could come your way anytime. It's a giant 48-foot by 18-foot curtain draped over ODOT's fleet trailer, which makes deliveries regularly all over the state. On Wednesday, Feb. 21, it will be parked in front of the Capitol in Salem from 9 a.m. to 2 p.m. in conjunction with the monthly Oregon Transportation Commission meeting.

"This unique opportunity allows us to emphasize our message even more," said ODOT Director Matt Garrett, a champion of the safety campaign. "Whenever we can remind folks to slow down and be aware in a work zone — or anytime they're traveling — we'll take it."

In big, bold letters the bright orange curtain says, "Slow Down. Better Roads Ahead." ODOT has been promoting that slogan for the past year in a statewide campaign, and the curtain design was based on billboard ads created by ODOT's advertising agency, Gard and Gerber of Portland.

"ODOT's fleet trailer runs up and down the I-5 and I-84 corridors and all parts east, west, north and south," said Dick Fenske, ODOT Fleet manager. "We'll also make the curtained trailer available for safety fairs and other special events."

ODOT's work zone campaign has become increasingly important for the safety of Oregon motorists and highway workers because of the increased roadwork under the Oregon Transportation Investment Act. OTIA work around the state will reach its highest levels in the next several years. The curtain message joins ODOT's "Slow Down. Better Roads Ahead." campaign of billboards, bus boards, and public service announcements.
