"BOTTLE BILL" RULE CHANGES TO PROVIDE COUNTING OF MORE CONTAINERS FOR REFUNDS

STATE OF HAWAII, DEPARTMENT OF HEALTH SOLID AND HAZARDOUS WASTE BRANCH (DOCKET NO. R-2-06)

Under Sections 91-3 and 342G-109, Hawaii Revised Statutes ("HRS"), the Department of Health (DOH) will hold a public hearing to consider proposed amendments to Chapter 11-282, Hawaii Administrative Rules ("HAR"), "Deposit Beverage Container Recycling."

The amendment proposal increases the deposit beverage container load size that redemption centers are required to count on demand, from 49 to 200. This change will provide consumers with increased accuracy when redeeming deposit beverage containers.
