This report accounts for laboratory equipment purchases made pursuant to Act 160 Session Laws of Hawaii 2006, the Budget Act. Of the general fund appropriation for State Laboratory Services (HTH 710), the sum of \$377,500, was appropriated for fiscal year 2006-2007, to be expended by the department of health solely for the purpose of purchasing equipment for the state laboratory.

The status of funds appropriated is as follows:

\$16,500 for purchase of computers.

Status: Preparing Form T205 (Approval to Purchase Computer Hardware and Software) for acquisition of information technology equipment. Anticipate acquisition in late 2<sup>nd</sup> Quarter or early 3<sup>rd</sup> Quarter of FY 2007.

\$190,000 for the purchase of two autoclaves for the Medical Microbiology Branch.

Status: Received sole source approval for autoclave #1 on 10/27/06. Requesting updated price quotation. Anticipate acquisition in 2<sup>nd</sup> or 3<sup>rd</sup> Quarter of FY 2007 and execution of contract with vendor.

Autoclave #2 will need to go to competitive bid and we are working with State Procurement Office on this process. Acquisition anticipated for 3<sup>rd</sup> or 4<sup>th</sup> Quarter 2007.

\$25,000 for purchase of a refrigerated centrifuge.

Status: Updating price quotations. Acquisition anticipated in 2<sup>nd</sup> or 3<sup>rd</sup> Quarter of FY 2007.

\$131,000 for purchase of a polymerase chain reaction machine.

Status: Sought and received confirmation from department's Administrative Services Office that this is for polymerase chain reaction accessories. Updating all price quotations. Acquisition anticipated in 2<sup>nd</sup> and 3<sup>rd</sup> Quarter of FY 2007.

One accessory needs to be submitted for Chief Procurement Officer approval for sole source or exemption for bid. Anticipate acquisition in 3<sup>rd</sup> Quarter FY 2007.

\$15,000 for purchase of an ultra-low freezer.

Status: Updating price quotations. Acquisition anticipated in 2<sup>nd</sup> or 3<sup>rd</sup> Quarter of FY 2007.
