### Senate Concurrent Resolution No. 117, H.D. 1 2006 Progress Report of S.C.R. No. 117 Task Force

This progress report is written to satisfy a request in Senate Concurrent Resolution No. 117, H.D. 1 ("S.C.R. No. 117"). S.C.R. No. 117 requests that the Governor convene a task force to evaluate and recommend possible procedural, statutory, and public policy changes to minimize the census at Hawaii State Hospital and promote community-based health services for forensic patients. The Governor has convened a newly constituted Task Force pursuant to S.C.R. No. 117 ("Task Force"), which has met monthly since October 2006 and which remains committed to meeting or exceeding all requirements of the resolution.

At the time of this report, the SCR No. 117 Task Force has met on October 19, 2006, and November 16, 2006. The next two meetings are scheduled for December 14, 2006 and January 11, 2007. Subsequent meetings will occur monthly throughout 2007.

In the two meetings held thus far, the Task Force has focused primarily on setting the Task Force agenda and vision and on providing educational components regarding the forensic mental health systems and services in Hawaii. The Task Force has had a chance to introduce themselves and to set preliminary topics for discussion. We have also participated in two presentations from the State of Hawaii, Department of Health ("DOH"). The first presentation was co-led by the Hawaii State Hospital ("HSH") Administrator and Medical Director, and it focused on challenges faced at HSH regarding the census, patient mix, physical plant issues, and the increasing number of forensic patients at HSH. The second presentation was co-led by the DOH Adult Mental Health Division (AMHD) Forensic Services Director and the Deputy Attorney General assigned to provide advice and counsel to AMHD. This second presentation focused on highlighting the intersections of the mental health and criminal justice systems, including presentation of relevant statutes and case law. It is anticipated that the December 2006 meeting will include a presentation on current AMHD forensic services and programs as well as an "environmental scan" of national forensic norms and standards.

Following each of the above presentations Task Force members have had the opportunity for question and answer periods from Task Force members. The Task Force intends to continue meeting monthly, in conformity with the resolution. It is anticipated that the Task Force will continue making progress, encouraging frank discussions with all stakeholders, and giving careful

consideration to potential procedural, statutory, and public policy changes related to forensic mental health services and consumers in Hawaii.
