PREQUALIFICATION FORM**

To be eligible to bid, applications must be **approved by ODOT**.

**GENERAL INFORMATION**

- All pages and sections must be completed and correct prior to approval
- **If a section does not apply, enter "n/a."**
- Do not use correction fluid.
- Use the latest version of the form from the above web sites.
- If accepted, an approval letter will be sent to the applicant.

**PART 1. Contractor Contact Information**

**Required**

Enter the **legal name** under which you wish to bid as it appears on the Secretary of State's Business Registry (<http://www.filinginoregon.com/business/index.htm>). An assumed business name is not a legal name; however, it can be used in conjunction with a legal name prefaced by "dba." A separate Prequalification Application is required for each separate legal entity.

Provide your physical (street) address for courier use. Provide your mailing address, web site, phone, fax number, county, contact person, title, phone number, and business e-mail address.

**PART 2. Contractor Company Information**

**Required**

Select the business structure type that fits your company and fill in the information requested.

**PART 3. Indicate Work Type Experience**

**Required**

Identify the Work Type(s) for which the company is requesting prequalification and the number of years the company has provided the specified work type(s).

**PART 4. Contractor Company Experience Information**

**Required**

1. Select yes or no. If yes, provide explanation.
2. For each Work Type(s) checked from PART 3, list up to a maximum of three (3) projects the company has completed during the past five (5) years or is currently working on, either as a Prime or a Subcontractor.
3. When filling in "**Type of Work**", use the same **Work Type name as checked from PART 3**.

**PART 5. Prequalification Form Certification Statement**

**Required**

Print name of authorized representative from Part 4, #3. Signature of authorized representative, date, and title.
