For the purposes of the Buy "American" provision, the list of eligible countries is provided to RUS by the Office of the U.S. Trade Representative. An "eligible country" is any country that applies with respect to the United States an agreement ensuring reciprocal access for United States products and services and United States suppliers to the markets of that country, as determined by the United States Trade Representative.

Many of our publications of complex formulas and tables – these are especially difficult to put into an accessible format that screen readers can decipher; however, we are working towards this mandate.
