The staff finds that you have supplied the requested information, and concludes that your plant does not appear to have conditions similar to those which led to the degradation at Davis-Besse. However, the staff may issue questions to confirm or verify the information that was provided in your 15-day response to Bulletin 2002-01. We will complete a full review of your response to Bulletin 2002-01 after we review your response to Items 2 and 3 of the Bulletin.
