**BASIC ALLOWANCE FOR SUBSISTENCE RATE INCREASES FOR CY 2006**

1. Replace paragraphs 250103, 250103.A and B as follows:

250103. Payment. The BAS entitlement is paid as a monthly rate. Effective January 1, 2006 the rates for BAS are as follows:

- A. The monthly BAS rate for officers is \$187.49
- B. The monthly BAS rates for enlisted members are:
  - 1. Enlisted BAS (standard) 272.26.
  - 2. BAS II \$544.52
