Mistakes are often made filling out this box. This code should be consistent with the client's marital status at the time of enrollment. For example, if the client was coded as married at enrollment, they cannot be coded as never married at termination.

### **Corrections!**

Let's say
you made a
mistake on
a CPMS
form, but
you already
sent it to us. What do
you do? Making
corrections is easy.
There are just four steps
that you need to follow:

- Make a photocopy of the CPMS form that needs correcting.
- 2. Using a RED pen, check and date the top left "Correction Box" on both the original and the photocopy (A&D form only).
- 3. In RED, neatly draw a line through the incorrect data and write the correct information as close to the incorrect data as possible (on both forms).

### **BHIP Update**

For those of you who may not be familiar with the Behavioral Health Integration Project (BHIP), here are a few key facts. The BHIP solution will be a comprehensive, statewide behavioral health information management system. The core of the BHIP solution will be an electronic health record (EHR). BHIP will be rolled out to the Oregon State Hospital first, and then to our community providers.

Implementation of BHIP in the Oregon State Hospital (OSH) is prompted by well-documented modern treatment needs. In addition, the Joint Commission has identified the lack of an information system as a major deficit, jeopardizing future accreditation at OSH and better services to patients.

We are now in the Planning Phase of BHIP. A significant amount of time needs to be spent in planning so that a quality product is selected that meets the core functional requirements.

As required by State rules, we are working towards getting the Request for Proposal (RFP) prepared so we can have a Quality Control and Planning vendor on board. Once this vendor is on board, one of their first tasks will be to prioritize the detailed functional requirements that have been identified by community and hospital folks. Then we will write an RFP for the software solution.
