<sup>4</sup> Limited Exception: Accepted from record keeping requirements. Must still meet the following requirements:

- Can read and speak the English language sufficiently to converse with the general public, to understand highway traffic signs and signals in the English language, to respond to official inquiries, and to make entries on reports and records;
- Can, by reason of experience, training, or both, safely operate the type of commercial motor vehicle he/she drives;
- Is physically qualified to drive a commercial motor vehicle in accordance with Subpart E — Physical Qualifications & Examinations of Part 391;
- Has a currently valid commercial motor vehicle operator's license issued only by one State or jurisdiction; and
- Is not disqualified to drive a commercial motor vehicle under the rules in §391.15.
