

Forest Supervisor Approves Forest RAC Projects



Recently, Forest Supervisor Claire Lavendel received and reviewed the projects recommend by the North and South Gifford Pinchot National Forest Resource Advisory Committees (RACs) for fiscal year 2003. Lavendel approved 20 projects totaling \$1, 475,714.63. These approved projects will provide for: 4,215 acres of natural resource improvements including weed control, thinning, watershed restoration, 159 miles of road maintenance, 35 miles of snowplowing for visitor access which will keep roads open between the Wind River Winter Sports area and Marble

Mountain Sno-Park on the south side of Mount St. Helens. Funds will also support 12,000+ information center visitor contacts, 3,000+ environmental education contacts, and restoration of a historic lookout a Burley Mountain near Randle, Wash. This past summer several volunteer groups worked together to repair a four-mile section of the Boundary Trail #1 that is located near Craggy Peak in the Dark Divide Roadless Area of the Gifford Pinchot National Forest. Eagle Scout candidate, Mark Passmore, and other Scouts from Troop #62 of Tacoma, Washington started working on the north end of the section of heavily rutted trail. "Because of the hard work provided by these groups to complete this repair project," said Harry Cody, Cowlitz Valley District Ranger, "the trail will be in great shape for many years to come."

This past Septemter the Gifford Pinchot in cooperation with the <u>Joint</u> <u>Task Force Six</u> worked with several federal, state, and county agencies to eradicate illegal drug growing opearations on public lands in Washington and Oregon. Johnston Ridge closed for the winter on Monday, October 28. The Mount St. Helens Visitor Center at Silver Lake, operated by Washington State Parks, will be open seven days a week from 9 a.m. to 4 p.m. throughout the winter season.
