

Current Mount St. Helens Eruption Marks Second Anniversary



September 23 marked the 2nd anniversary of the current eruptive period at Mount St. Helens. Following 18 years of eruptive quiescence, Mount St. Helens began showing signs of unrest in late September, 2004. The volcano continues to erupt today. Since dome growth began in October of 2004, there have been only two explosive events: one in mid-January, 2005 and the other early March, 2005. Neither event was preceded by precursory activity. Six of the seven spines to date were extruded during the first year of the current eruption. Activity over the past year

has been steadily ongoing but with a slower extrusion rate compared to the past year and there have been no explosive events in the past year. On July 21, the Forest reopened the climbing trail to the summit of Mount St. Helens allowing visitors to get a bird's eye view of the activity within the crater.

Invasive Plants Draft EIS Available for Comment

The Gifford Pinchot National Forest and the Columbia River Gorge National Scenic Area are seeking public review and comment on a Draft Environmental Impact Statement (DEIS) entitled "Beyond Prevention: Site-specific Invasive Plant Treatment Project." Approximately 2,700 acres are estimated currently to need treatment. Target invasive species includes knapweeds, hawkweeds, knotweeds, bull thistle, hounds tongue, and reed canary grass, to name a few. The DEIS discloses the effects of treating invasive plants on the Gifford Pinchot National Forest and the Columbia River Gorge National Scenic Area.

Mount St. Helens Visitor Centers Shift to Winter Schedule

As winter approaches, Mount St. Helens National Volcanic Monument visitor centers are shifting to seasonal schedules. The Johnston Ridge Observatory closed for the winter season starting Monday, October 30. The Coldwater Ridge Visitor Center will switch to a new winter schedule starting Monday, October 30. The Coldwater center will be open three days a week, Saturday through Monday from 10



a.m. to 4 p.m. until December 31, except Christmas Day. The Coldwater center will close for the month of January when weather conditions are poor and visitation generally low. On February 1, 2007, the Coldwater Ridge Visitor Center will reopen to the public operating five days a week, Thursday through Monday from 10 a.m. to 5 p.m., until May 17 when summer schedules resume.

Christmas Trees



It's time to start thinking about finding that special Christmas tree. Beginning Friday, November 17, permits will be available at several locations for cutting a Christmas tree from the Forest. Permits may be purchased for \$5 per tree at all Ranger District offices, Forest Headquarters in Vancouver, and at local commercial vendors.
