

## Fall Storms Impact Forest Roads and Recreation Sites

November's record rainfall and subsequent flooding affected roads, bridges, trails, and Sno-Parks across the Forest. November's rain was followed by a large windstorm on December 14, which brought down trees across roads and trails. The hardest hit areas on the Forest were the Cowlitz Valley Ranger District and parts of the Mount St. Helens National Volcanic Monument. On November 7, the Cowlitz River crested at more than 7-feet above flood stage. Also on the South side of Mount St. Helens, the June Lake weather station recorded 15.2 inches of rain in a 24-hour period, between November 6-7, setting a state record. Heavy snowfall followed the flood and storm events cutting off access to assess some of the damage. As a result, spring and summer snowmelt will reveal additional road and trail damage. The total damage to Forest roads and recreation facilities is currently estimated at more than \$17.3 million. Forest staff is currently working internally and with

### **Recreation Site Facility Master Planning**

Recently, Forest staff began to take a close look at the Forest's developed recreation program – opportunities offered, facilities, visitor use, preferences, and recreation trends. Like many other forests in the Northwest, the Gifford Pinchot has many developed recreation sites (including campgrounds, picnic areas, boat launches, and trailheads), some with costly infrastructure to maintain, such as water systems. Some of these sites were built 30-50 years ago and are showing their age. Visitor preferences and demand have changed since the 1950s-60s. As part of a National process, Recreation Site Facility Master Planning (RS-FMP), Forest personnel are reviewing these sites. Through this process and with the public's help, the Forest can make more informed decisions on where to focus limited resources to best meet visitor demand, and develop a 5-year work plan. ### New Interagency Recreation Pass Replaces Golden Passports



A new interagency recreation pass that will benefit visitors to national public lands was unveiled in December. The pass combines the benefits of existing recreation passes from five federal agencies into one pass, the "America the Beautiful – National Parks and Federal Recreational Lands Interagency Pass." Access to most public lands remains free. The new program replaces the Golden Eagle, Golden Age, and the Golden Access Passports as well as the

National Parks Pass. Existing Golden passes will remain valid until expired, lost, or stolen. Sales of the new pass started in January 2007. A new annual interagency pass costs \$80. Senior passes are still \$10 and the disabled Access pass is still free. For more information, <u>please visit the Forest website</u>.
