Mount St. Helens New Lava Dome Continues to Grow: Growth of the new lava dome inside the crater of Mount St. Helens continues, accompanied by low rates of seismicity, low emissions of steam and volcanic gases, and minor production of ash. The new dome, known as the "whaleback," is approximately one-third the size of the old dome which grew during the early 1980's. Planning Rule Announced: The Forest Service unveiled its landmark update to the 1976 National Forest Management Act last month. The new rule will make forest planning more timely and cost-effective. Currently the forest planning process generally takes 5-7 years to revise a 15-year management plan. Under the new rule, forest plan revisions will take approximately 2-3 years, with a comprehensive evaluation of the plan to be completed every five years to ensure it is meeting goals and objectives.

The new rule directs forest managers to take into account the best available science to protect air, water, wildlife, and other important natural resources. The new rule neither promotes nor discourages any particular forest use, such as recreation, grazing, timber harvest, or mineral development. Decisions regarding such uses will be made on a forest-by-forest basis and will be based on local conditions, science and public input. The Gifford Pinchot Forest Plan is slated for review starting in 2010. For more information about the new planning rule visit the National Forest Management Act web page.

Forest Service to Celebrate Its Centennial in 2005: The USDA Forest Service will celebrate its 100th anniversary on July 1, 2005. A number of special projects and events are planned to commemorate the Forest Service Centennial. At the national level, the Forest Service will participate in the 2005 Smithsonian Folklife Festival, release a documentary film about the history of the agency, and host a Centennial Congress in Washington, D.C. Many National Forests are planning local Centennial activities for 2005.

White Pass Open House Meetings Scheduled in February:

The Forest Service has scheduled a series of open house meetings to answer questions and take comments on the Draft Environmental Impact Statement (DEIS) for the <u>proposed expansion of the White Pass Ski Area</u>. The DEIS

for the proposed expansion of the White Pass Ski Area on U.S. 12 straddling the Gifford Pinchot and Okanogan-Wenatchee National Forests is now available for review. Because the DEIS was released over the holidays, there is an extended 60-day comment period. Accordingly, comments should be postmarked no later than February 22, 2005.



Open house meetings will be held in early February in Randle and Olympia, Wash. Both sessions will be from 7 p.m. to 9 p.m. On Wednesday, February 2, a session will be held at the Randle Fire Hall in Randle, Wash., and another session will be held the following evening, Thursday, February 3, at the Olympic National Forest Headquarters in Olympia, Wash. Cabin Fever Festival Features Forest Service Centennial:



The Gifford Pinchot National Forest will begin the Forest Service Centennial celebration with a presentation and stories about Forest history, and a ski trip to the historic Gotchen Guard station. These activities are part of the fourth annual Trout Lake, Wash., Cabin Fever Festival. Both events

will be led by Forest Archaeologists Rick McClure and Cheryl Mack. An evening of story sharing and a presentation of local historical events will be held at the Trout Lake School on Saturday, January 29, starting at 7 p.m. On Sunday, January 30, the Gotchen Creek Guard Station, the oldest building on the Forest, will be open to the public from 10 a.m. to 3 p.m. Skiers will be treated to refreshments while learning more about the history of the guard station. A guided tour to the guard station will leave from the Smith Butte Sno-Park at 10 a.m. A map to the guard station will be posted at the Sno-Park and the trail will be flagged.

Youth Fees Dropped at Mount St. Helens Visitor Centers:

Beginning January 2, 2005, young people under age 16 no longer have to pay admission fees at three Mount St. Helens visitor centers. The change is required by the recently passed "Federal Lands Recreation Enhancement Act," which replaced the eight-year old Recreation Fee Demonstration Program. Under both, at least 80 percent of fees stay on site for maintenance and operations. The new fee changes affect the Mount St. Helens Visitor Center at Silver Lake, Coldwater Ridge Visitor Center and Johnston Ridge Observatory on State Route 504.
